Wayne County Board of Supervisors

Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 7th day of March 2023, in the Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due note of meeting subject to said Code Section.

Present were Lance Lange, Don Seams, Chris Moore, members of the Board. Also in attendance: Dylan Davenport, Ericka Graves, Hayden Reece, and Damian Boyd, and Tiena Lewis.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page.

Unless otherwise noted, all motions are approved unanimously by all Board members present.

Lange called the meeting to order at 10:03AM and took roll call.

Pledge of Allegiance

Seams made a motion to approve the agenda with the addition of Wayne County Farm Fencing Issue and ICIT Assessment between item number 16 and 17, seconded by Moore.

Moore made a motion to approve February 21, 2023, minutes, seconded by Seams.

Seams made a motion to approve March 03, 2023, payroll, seconded by Moore.

Moore made a motion to approve March 07, 2023, claim set, seconded by Seams.

Seams asked for a recess to set up the computer for the public hearing.

Don made a motion to open Public Hearing at 10:15 AM, seconded by Moore, Cory B. Metzger from Resource Consulting Engineers, LLC joined the meeting by Zoom.

Lange gave Metzger the floor to answer any questions. Metzger stated that documents for rebid for the Courthouse HAVC improvement project with modifications from the original bid will be issued with the Board approval. The biggest change in the modifications will be the flexibility, schedule, and timing of the project. Slight modifications to design include simplifying the design of ceiling of the courtroom, adjusting some insulation requirements for system components, and making some modifications due to the results of asbestos testing. Boyd from Gillman Home Comfort asked Metzger several questions. All documents will be posted pending approval from public hearing. Metzger stated that this would be a single prime bid. We will work with contractors so that work is not started until all equipment is available. All employees of the courthouse will be moved out so that contractors have an empty space to do the work in. Lange read through the schedule for completion of the work and copies were given to contractors present.

Seams made the motion to close the Public Hearing @ 10:31 AM, Moore seconded the motion. Moore made a motion to approve the release of the re-bidding documents, seconded by Seams. Seams made a motion to table the approval of the Conservation Capital Asset Addition; 2015 Cat 249D Skid Steer, seconded by Moore.

Moore moved to sign the Memorandum of Understanding (MOU) for reimbursement from the MH/DS after some discussion, Seconded by Seams.

Davenport gave the Board an update on what Secondary Roads was working on.

Seams made a motion to table the Permanent Right-Of Way Acquisition of P3036 Bridge (Birch Road), seconded by Moore.

Lange read the Resolution 23-25, Destruction of Noxious Weed. Moore made a motion to approve Resolution 23-25 as presented, seconded by Seams. Board members made some comments about the noxious weeds after resolution was passed.

Moore made the motion to have an ICIT Assessment at the cost of \$3000, after explaining the purpose of assessment and estimated date of assessment, seconded by Seams.

Seams gave an update of availability of the current panic buttons for county offices and stated current buttons are not manufactured any more. More research will need to be done since no one knows if we can add more buttons to our current system even if we could purchase used buttons. Seams made a motion to table the panic buttons for the county offices, Moore seconded.

Moore made a motion to take the old courthouse office furniture, which was explained by Lange how the courthouse acquired the furniture, to Redeemed in Corydon, Seconded by Seams.

Moore moved to let the current tenant of the county farm remove the road fence and the brush in that area in exchange for the steel post the tenant takes out, seconded by Seams. It was also noted that ICIT Assessment was overlooked on the agenda when it was added to agenda.

There were no department monthly reports.

Seams made a motion 11:02 AM to go into closed session per 21.58 (1i) Personnel issue, Moore seconded

Seams made a motion to go back into open session at 11:34 AM, seconded by Moore. It was stated a personnel issue was discussed with not action taken.

During discussion, Seams gave an update on Randy's Clark's request to purchase some land in the City of Millerton and stated it would be Randy's responsibility to move forward. Moore stated that a future agenda item would be to get the payroll of salary and the hourly people on the same schedule. The Board feels this would help them in doing a review of payroll. Lewis explained how the present payroll system works.

Each board member gave a report of meetings they had attended.
