# **Wayne County Board of Supervisors**

The Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 3rd day of July 2023, in the Lower-level Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due note of meeting subject to said Code Section.

Present were Lance Lange, Don Seams, Chris Moore, members of the Board. Also in attendance: Nancy Bennett, Todd Kucera, Dillon Davenport, Jenny Nickell, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page. **Unless otherwise noted, all motions are approved unanimously by all Board members present.** 

Lange called the meeting to order at 10:00AM and took roll call.

Pledge of Allegiance

Seams made a motion to approve the agenda, seconded by Moore.

Lange made a motion to approve June 30, 2023, Minutes, seconded by Seams.

Seams made a motion to approve July 3, 2023, Claim Set, seconded by Moore.

No public comments on agenda items.

Todd Kucera, resident of Wayne County was present to visit with the Board of Supervisors and the County Engineer about the procedure for determining where in the county brush grinding was going to occur and if it is done on a schedule or as need basis. Engineer Dillon Davenport reported that it is a combination. Kucera asked if residents could somehow receive notification when scheduled work was going to be done in their area. Seams stated that maybe some options could be looked at when Secondary Roads gets in a more proactive state. Kucera thanked them all for their time.

Engineer Davenport gave an update on the road department. The pilings on the Sunny Slope bridge are driven and currently forming the backwalls and diaphragms. The decking should be ready to pour in 2 to 3 weeks. The crew is working on roadside mowing. The bridge on Birch Road is complete and back open for traffic. Seeding still needs completed. The DOT seeding date starts in September. Highway J46 is completed and back open. Rock shoulders are a little soft and may need additional attention.
