## Wayne County Board of Supervisors

The regular scheduled meeting of the Wayne County Board of Supervisors was held on the 20th day of February 2024, in the Wayne County Development Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were Lance Lange, Chris Moore, and Todd Wilson, members of the Board. Also in attendance: Kellie Anderson, Dillon Davenport, Dan Carpenter, Don Seams, Savanah Sandy, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page. **Unless otherwise noted, all motions are approved unanimously by all Board members present.** 

Lange called the meeting to order at 10:00AM and took roll call.

Pledge of Allegiance

Lange made a motion to approve the agenda, seconded by Wilson.

Moore made a motion to approve February 6, 2024, minutes, seconded by Wilson.

Wilson made a motion to approve February 2, 7 & 13, 2024 Budget Work Session Minutes, seconded by Moore.

Wilson made a motion to approve the February 16, 2024, payroll, seconded by Moore.

Lange made a motion to approve February 20, 2024, the claim set, seconded by Wilson.

There were no public comments on agenda items.

One sealed bid was submitted for the Millerton real estate sold by the County. The bid was made by Randy and Barb Clark for \$750. Moore made the motion to accept the bid, seconded by Wilson. Closing date will be set by County Attorney, Al Wilson.

Engineer Dillon Davenport reported that the bridge crew is working on the 105<sup>th</sup> bridge by the feedlot south of Allerton. The SS4A Federal Grant has been approved and a consultant is working on developing a local Road Safety Plan for the participating counties in the program. Fuel bid documents for the shop and remote locations are being created and will be published soon. Davenport will also be soliciting bids for commonly used metal culverts. The dust control policy is being reviewed/ revised and will be presented for Supervisors approval during the next regular scheduled meeting. The tree grinder is working on King Road moving toward 60<sup>th</sup> Street and then proceed to Linden Road.

Moore made a motion to accept and approve the fourteen (14) Rural Revitalization Abatement applications for 2024 assessment year, seconded by Wilson.

Lange made a motion to approve Resolution 24-18 to set proposed tax hearing, seconded by Wilson. Resolution 24-18 Set an additional Proposed Tax Hearing for FY25 Budget as required by HF718

Moore made a motion to approve the Clerk of Court January report, seconded by Wilson. Deposits were \$3,115.32.

## Supervisor Meetings:

Lange attended the Wayne County Conservation meeting. The Conservation crew is working on signage and clearing brush at the parks. They have done a couple of control burns at Bobwhite and are leveling some camping sites. Lange also attended a Wayne County Development Board meeting, and that board is working to identify and establish sustainable funding sources.

Wilson & Lange were both scheduled to attend the Chariton Valley Planning and Development TAC meeting. However, it was cancelled for lack of quorum. All three supervisors attended budget work sessions with the county departments/offices.

Moore has attended several public health board meetings in the last month. The legal lawsuit that was brought against the Public Health Board, the sanitationist and Wayne County has been dismissed by Federal Court. The board has hired Denise Conway as the interim Director to oversee day-to-day operations for Public Health Nursing/Homemakers. June 1st is the target date to have a new director hired. The board is scheduled to meet March 4<sup>th</sup> for strategic planning.

## No Discussion

Public Comments: Don Seams asked for clarification of the lawsuit. Moore responded that the lawsuit was brought against the county by a sewer septic system contractor. Whose license was pulled for one year for not following proper procedures. Seams also asked who was hired as Interim Director for Public Health/Homemakers. Denise Conway was hired as Interim Director.
