Wayne County Board of Supervisors

The regular scheduled meeting of the Wayne County Board of Supervisors was held on the 30th day of April 2024, in the Wayne County Development Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were Lance Lange, Chris Moore, and Todd Wilson, members of the Board. Also in attendance: Mendy Middlebrook, Joella Perry, Kellie Anderson, Neal Tapken, Tim Cassidy, Dillon Davenport, Dan Carpenter, James Wiltamuth, Brandon Carpenter, Savanah Sandy, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page. Unless otherwise noted, all motions are approved unanimously by all Board members present.

Lange called the meeting to order at 10:00AM and took roll call.

Pledge of Allegiance

Wilson made a motion to approve the agenda, seconded by Moore.

Lange made a motion to approve April 16, 2024, regular meeting minutes, seconded by Moore.

Moore made a motion to approve April 26, 2024, payroll, seconded by Wilson.

Wilson made a motion to approve April 30, 2024, claim set, seconded by Moore.

There were no public comments on agenda items.

Mendy Middlebrook presented and requested the Second Amended and Restated 28E Agreement for the Heart of Iowa Region be approved and signed.

Adair, Adams, Audubon, Clarke, Dallas, Decatur, Guthrie, Lucas, Marion, Ringgold, Taylor, Union, Wayne counties will make up the new region. Member counties shall have the discretion to appoint a total of six (6) Board of Supervisors pursuant to lowa Code 225C.57(2)(c)(1) to the governing Board. Moore will try to be one of the six appointed to the governing board.

Moore made a motion to approve the Second Amendment and Restated 28E for the Heart of Iowa Region, seconded by Wilson.

Engineer Dillon Davenport gave Engineer Office/Secondary Road Update.

- The bridge crew on 105th St near Allerton; deck steal is almost tied and hoping to pour concrete in the next two (2) to three (3)
- Some new issues have developed since the recent change in the weather. The issues are being reviewed and evaluated.
- Tree grinding continues on 210th St south of Hwy 2 and Davis Rd south of Allerton. When grinding is complete, the crew will begin replacing railroad tanker culverts in the area.
- Corrugated metal pipe (CMP) from the recent bid package is being delivered.
- The Bridge replacement of 250th St Northeast of Seymour is moving along. Got clearance from the DOT to begin right-of-way land acquisition process. This will take several months. The letting is scheduled for December 2024.

Joella Perry Veteran Affairs Director requested that David Dotts be appointed as a Wayne County Veteran Affairs Commissioner for a three (3) year term to begin June 1, 2024. David Dotts was the only applicant that applied.

Wilson made a motion to appoint David Dotts as Wayne County Commissioner for a three (3) term, seconded by Wilson.

Lange made a motion to approve the letter of support for the Circle of Freedom from the Board of Supervisors, seconded by Wilson.

Lange made a motion to set a public hearing to Amend the Wayne County FY24 Budget, seconded by Moore.

Tim Cassidy & Neal Tapken from Heartland Co-op visited with the supervisors about their vision of building a state-of-the-art grain elevator terminal to efficiently receive large volumes of corn & soybeans from inbound semis and transfer to large 110 car "shuttle" trains in Wayne County. The location site is west of Millerton on J22 near Hwy 14 while utilizing the Union Pacific Railway infrastructure. Currently Heartland Co-op is in the process of acquiring 160 acres of land for the project. Brandon Carpenter, Wayne

County Assessor was present and asked what tax abatement incentives other counties were offering. Carpenter also asked how other counties were classifying the acres. Cassidy and Tapken were unable to answer his questions but will gather the information and report back to the Assessor. Moore made a motion to support a tax abatement for the Heartland Co-op project, seconded by Wilson.

Moore made a motion to approve the Public Health Nursing February Report, seconded by Lange. Deposits were \$22,269.14. Moore made a motion to approve the Public Health Nursing March Report, seconded by Lange. Deposits were \$21,334.60.

Kellie Anderson, Wayne County Development Director invited everyone to First Thursday Coffee on May 2 @ 7:30AM at the Wayne Co. Development Corporation, 208 S Franklin St, Corydon.

Supervisor Meeting Updates

Moore attended a Board of Health Meeting. Everything is running smoothly there.

Wilson attended the DECAT meeting and learning about the organization and the service they provide. He also attended the 1015 Transit meeting and everything is the same there. Wilson & Dooley also participated in a zoom call regarding OPIOID fund settlement that the county is receiving. Wilson is in the process of developing an OPIOID fund advisory board. Lange did not have any meetings to report on.

Discussion items: Lange would like to discuss options for implementing an employee timeclock process. The Board of Supervisors would like a work session with Chelsea Stoll from Iowa Negotiation & Consulting Services for Tuesday, May 7th @ 10AM to review the Employee Handbook. Moore discussed the need to help township trustees and clerks with challenges that they are facing concerning the cemeteries throughout the county. There are some options available to help them with taking ariel photos and mapping the plots. Joella Perry, VA Director and the Veterans Affair Commission have done extensive work with all 52 cemeteries located in Wayne County and would love the opportunity to be a part of this cemetery project.

Public Comments: James Wiltamuth was present and volunteered to sit on the OPIOID Fund Advisory Board.
