

Wayne County Board of Supervisors

The regular scheduled meeting of the Wayne County Board of Supervisors was held on the 29th day of October 2024, at the Wayne County Courthouse in the Lower-Level Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present- Lance Lange, Chris Moore, and Todd Wilson, members of the Board. Also in attendance: John Buttz, Kellie Anderson, Engineer Dillon Davenport, Dan Carpenter, Don Seams, Jen Reed, Teresa Evans, Dr. Joel Wells and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page.
Unless otherwise noted, all motions are approved unanimously by all Board members present.

Lange called the meeting to order at 10:00AM and took roll call.

Pledge of Allegiance

Moore made a motion to approve the agenda, seconded by Wilson.

Wilson made a motion to approve October 15, 2024, regular meeting minutes, seconded by Moore.

Moore made a motion to approve October 25, 2024, payroll, seconded by Wilson.

Lange made a motion to approve October 29, 2024, claim set, seconded by Wilson.

There were no public comments on agenda items.

John Buttz, Owner of Southern Iowa Plumbing was present. Buttz is a septic system contractor in Wayne County. Buttz requested the Board of Supervisors to focus on consistency and quality when septic systems are certified for the sake of county residents. He expressed concerns about dirt compaction around the septic systems because of the type of dirt in southern Iowa. He also expressed concern about sand trap filters being used and causing homeowners issues. Buttz also informed the supervisors that training was available from the state if the sanitarian needed further training. The Supervisors thanked Buttz for the information and reminded him that sanitarian works under the authority of the Board of Health. Buttz was to meet with the Board of Health members, Dr Joel Wells and Chris Moore after the supervisor's meeting to discuss his concerns further.

Engineer Dillon Davenport gave Engineer Office/Secondary Road Update.

- The roadside mowers are running now.
- Grinding excavator is working Northwest of Millerton
- Culvert are being repaired and replaced
- Bridge rehab on 205th Street south of Edison has begun.
- Final plans for the culvert lining project on Highway S40 west of Seymour and Highway J46 south to the Missouri border is coming together and the project is scheduled for Summer 2025.

Wayne County Conservation Board currently has two vacancies, from Mike Lewis and Diane Schroder-Olson stepping down from their positions. Three (3) individuals are interested in filling the vacancy. Those individuals are Brady Bloomquist, Don Seams and Tim Gaul. Wilson made a motion to appoint Don Seams and Tim Gaul to the Wayne County Conservation Board, seconded by Moore.

Lange made a motion to reschedule December 24th, 2024, Board of Supervisors meeting to Monday, December 23rd because of the county offices being closed for the holiday, seconded by Wilson.

Department Monthly Reports

Auditor Dooley reported that the FY24 Cost Allocation Plan was complete. Cost Advisory Services, Inc compiled the data submitted to the State on our behalf for reimbursement. The county should receive in FY26 for indirect cost associated with the local DHHS office located in the courthouse approximately \$29,138.

Supervisor Meeting Updates:

Lange attended the Trunk or Treat event held at Bob White campground. He will be attending a SCICAP meeting tomorrow.

Wilson attended the 10-15 transit meeting. A non-profit entity is being established to help with funding transportation for veterans.

Moore attended the Heart of Iowa Community Service Regional meeting. The region is doing very well at implementing programs and following the state model. The Heart of Iowa has submitted an intent to bid on this RFP for the Behavioral Health Administrative Service Organization (BH-ASO). A 90-minute presentation is the next step in the process.

Discussion: Moore is working with the City of Millerton and The Heartland Co-op on tax abatement. The new facility is located on the west edge of Millerton. Currently, they are pouring concrete for bins. There are some concerns about the county highway J22 holding up under the increased semi traffic. Engineer Davenport is aware of the concerns and looking into different options. Sheriff Davis is advertising for a deputy sheriff position. The deadline to apply is 5:00PM on November 15th. The civil test will be administered on November 26th. Anyone interested should contact Sheriff Davis.

Public Comments: Don Seams commented that the concrete patches throughout the county are very nice and smooth. Seams also stated that the county sanitarian does a good job and is very knowledgeable about septic systems in his opinion while being a county supervisor.
