Wayne County Board of Supervisors FY26 Budget Work Session

The FY26 Budget Work Session of the Wayne County Board of Supervisors was held on the 27th day of January 2025, in the Wayne County Courthouse Lower-Level Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were Lance Lange, Chris Moore, and Todd Wilson, members of the Board. Also in attendance: IT Director Chase Clark, Wayne County Conservation Director Kenny Banks, Treasurer Amanda Cooper, County Attorney Al Wilson, Sheriff Keith Davis, Recorder Angie Horton, and Auditor Michelle Dooley.

Moore called the meeting to order at 10:00AM and took roll call.

Auditor Dooley shared the following information with the Board before meeting with the Department Heads/Elected Officials. The maximum allowed General Basic Fund Levy is 4.19131. This rate will generate \$1,912,667 in property tax dollars. The maximum allowed Rural Service Basic Fund Levy is 3.91089. This rate will generate \$1,409,839 in property tax dollars.
