Wayne County Board of Supervisors

The regular scheduled meeting of the Wayne County Board of Supervisors was held on the 4th day of February 2025, at the Wayne County Courthouse in the Lower-Level Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present- Chris Moore, Todd Wilson, and Lance Lange members of the Board. Also in attendance: Engineer Dillon Davenport, Dan Carpenter, Joella Perry, Hubert Staggs, Don Seams, Savanah Sandy, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page. Unless otherwise noted, all motions are approved unanimously by all Board members present.

Moore called the meeting to order at 10:00AM and took roll call.

Pledge of Allegiance

Lange made a motion to approve the agenda, seconded by Wilson.

Lange made a motion to approve January 21, 2025, Regular Meeting minutes, seconded by Wilson.

Wilson made a motion to approve January 27, 2025, FY26 Budget Work Session Minutes, seconded by Lange.

Lange made a motion to approve January 28, 2025, FY26 Budget Work Session Minutes, seconded by Wilson.

Wilson made a motion to approve January 29, 2025, FY26 Budget Work Session Minutes, seconded by Lange.

Lange made a motion to approve January 31, 2025, payroll, seconded by Wilson.

Wilson made a motion to approve February 4, 2025, claim set, seconded by Lance.

No public comments on agenda items.

Veteran Affair's Service Office, Joella Perry and Commissioner, Hubert Staggs were unable to present a quilt to a veteran because of unforeseen circumstances. Perry did give an update for the office though. Currently, 108 veterans and 13 widows are receiving veteran benefits. In January, \$202,377 federal benefits were received.

Engineer Dillon Davenport gave an Engineer's Office and Secondary Road Department update.

Moore introduced RESOLUTION 25-15.

WHEREAS, the Board of Supervisors, hereafter referred to as "the Board", believes the project BROS-C093(97)--8J-93, hereafter referred to as "the project" is in the best interest of Wayne County, Iowa, and the residents thereof. The project is defined as Bridge Replacement on 245th St, Over Walnut Creek; and

WHEREAS, the Board has sought appropriate professional guidance for the concept and planning for the project and followed the steps as required by the Code of Iowa for notifications, hearings, and bidding/letting; and WHEREAS, The Board finds this resolution appropriate and necessary to protect, preserve, and improve the rights, privileges, property, peace, safety, health, welfare, comfort, and convenience of Wayne County and its citizens, all as provided for in and permitted by section 331.301 of the Code of Iowa; and

IT IS THEREFORE RESOLVED by Board to accept the bid from Manatt's Inc., DBA Cunningham-Reis in the amount of \$626,193.72 and awards the associated contract(s) to the same;

BE IT FURTHER RESOLVED that all other resolutions or parts of resolutions in conflict with this resolution are hereby repealed. If any part of this resolution is adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the resolution or action of The Board as a whole or any part thereof not adjudged invalid or unconstitutional. This resolution shall be in full force and effect from and after the date of its approval as provided by law; and

BE IT FURTHER RESOLVED by the Board of Supervisors of Wayne County, Iowa, that after receiving the necessary contract documents, including but not limited to, the contractor's bond and certificate of insurance, Dillon Davenport, the County Engineer for Wayne County, Iowa, be and is hereby designated, authorized, and empowered on behalf of the Board of Supervisors of said County to execute the contracts in connection with the afore awarded construction project let through the DOT for this county.

Lange made a motion to approve Resolution 25-15, seconded by Moore.

Assist Engineer, Dan Carpenter also serves as the Title VI Coordinator for Wayne County. Since Chris Moore was named the Board of Supervisor Chairman for 2025, Carpenter needed to update Title VI Non-Discrimination Agreement with the Iowa Department of Transportation, the 2025 Standard Title VI Non-Discrimination Assurance, The Policy Statement and Title VI Notice to the Public.

Lange made a motion to table appointing a Mental Health Advocate for Wayne County, seconded by Wilson.

Moore made a motion to table appointing a new Public Health Board Member to fill the vacancy created by Penny Fetters resignation, seconded by Lange.

Moore introduced Resolution 25-14.

Resolution taking action to set public hearing on proposal to enter into a General Obligation Emergency Communications Loan Agreement and to borrow money thereunder

WHEREAS, the Board of Supervisors (the "Board") of Wayne County, Iowa (the "County") proposes to authorize the County to enter into a loan agreement (the "Loan Agreement") and to borrow money thereunder in a principal amount not to exceed \$1,500,000, pursuant to the provisions of Section 331.402 of the Code of Iowa, for the purpose of paying the costs, to that extent, of equipping and improving to the County's E-911/emergency communications system (the "Project"), and it is necessary to fix a date of meeting of the Board at which it is proposed to hold a public hearing on the Loan Agreement and to give notice thereof as required by such law;

NOW, THEREFORE, Be It Resolved by the Board of Supervisors of Wayne County, Iowa, as follows:

Section 1. This Board shall meet on February 18, 2025, at the Wayne County Courthouse, Lower-level Conference Room, Corydon, Iowa, at 10:00 a.m., at which time and place a hearing will be held and additional action taken on the Loan Agreement.

Section 2. The County Auditor is hereby directed to give notice of the proposed action on the Loan Agreement setting forth the amount and purpose thereof, the time when and place where the said meeting will be held, by publication at least once, not less than four (4) and not more than twenty (20) days before the hearing, in a legal newspaper of general circulation in the County. The notice shall be in substantially the following form:

NOTICE OF PUBLIC HEARING ON PROPOSAL TO ENTER INTO A LOAN AGREEMENT AND TO BORROW MONEY THEREUNDER IN A PRINCIPAL AMOUNT NOT TO EXCEED \$1,500,000 (GENERAL OBLIGATION)

The Board of Supervisors of Wayne County, Iowa, will meet on February 18, 2025, at the Wayne County Courthouse, Lower-level Conference Room, Corydon, Iowa, at 10:00 o'clock a.m., for the purpose holding a public hearing on a proposal to enter into a loan agreement (the "Loan Agreement") and to borrow money thereunder in a principal amount not to exceed \$1,500,000 for the purpose of paying the costs, to that extent, of equipping and improving to the County's E-911/emergency communications system.

The Loan Agreement is proposed to be entered into pursuant to authority contained in Section 331.402 of the Code of Iowa. The Loan Agreement will constitute a general obligation of the County.

It is estimated the annual increase in property taxes on a residential property with an actual valuation of one hundred thousand dollars resulting from the County entering into the Loan Agreement will be \$21.65, however the Board of Supervisors may determine for any fiscal year while the Loan Agreement is outstanding to budget other available revenues to the payment of some or all of the debt service coming due thereunder. At that time and place, oral or written objections may be filed or made to the proposal to enter into the Loan Agreement. After receiving objections, the County may determine to enter into the Loan Agreement, in which case, the decision will be final unless appealed to the District Court within fifteen (15) days thereafter.

Section 3. Pursuant to Section 1.150-2 of the Income Tax Regulations (the "Regulations") of the Internal Revenue Service, the County declares (a) that it intends to undertake the Project which is reasonably estimated to cost \$1,500,000, (b) that other than (i) expenditures to be paid or reimbursed from sources other than the issuance of bonds, notes or other obligations (the "Bonds"), or (ii) expenditures made not earlier than 60 days prior to the date of this Resolution or a previous intent resolution of the County, or (iii) expenditures amounting to the lesser of \$100,000 or 5% of the proceeds of the Bonds, or (iv) expenditures constituting preliminary expenditures as defined in Section 1.150-2(f)(2) of the Regulations, no expenditures for the Project has heretofore been made by the County and no expenditures will be made by the County until after the date of this Resolution or a prior intent resolution of the County reasonably expects to reimburse the expenditures made for costs of the County out of the proceeds of the Bonds. This declaration is a declaration of official intent adopted pursuant to Section 1.150-2 of the Regulations.

Section 4. All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

Section 5. This resolution shall be in full force and effect immediately upon its adoption and approval, as provided by law.

Lange made a motion to approve Resolution 25-14, seconded by Wilson.

Wilson would like a work session with all the entities involved with the lowa Statewide Interoperability Communication System (ISICS) in Wayne County.

Lange attended the South-Central Iowa Community Action Program (SCICAP) meeting. They reviewed budgets and visited about the Headstart program and tax services offered.

Wilson attended the South-Central Iowa Workforce Development meeting. They are working with new student orientation. Wilson also attended the Southeast Iowa Response Group (SIRG) meeting with Bill Byrns. The 10-15 Transit meeting was held by phone. Wilson also attended the statewide Supervisor's meeting.

Moore attended the Assessor's conference Board meeting to review FY26 preliminary budget. Moore attended the 911 meeting, and they elected new officers. Moore also attended the statewide supervisor's meeting.

No Discussion Items

Public Comments: Don Seams asked what the qualifications for a mental health advocate are. Moore reference lowa Code Section 229.19. Seams also asked about the public hearing for loan proposal not greater than \$1,500,000 and he wanted to confirm that taxpayers could see an increase \$21.65 in property tax liability for every \$100,000 taxable value they own if the county moves forward with the essential service bond for the ISICS Project.
