

## Wayne County Board of Supervisors

A regular meeting of the Wayne County Board of Supervisors was held on the 8th day of July 2025, at the Wayne County Courthouse in the Lower-Level Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present- Chris Moore, Todd Wilson, and Lance Lange members of the Board. Also in attendance: Dillon Davenport, Dan Carpenter, Teresa Evans, Kellie Anderson, Don Seams, and Michelle Dooley.

The Corydon Times Republican & Humeston New Era recorded the Board of Supervisors regular session meeting and will post on their Facebook page.

**Unless otherwise noted, all motions are approved unanimously by all Board members present.**

Moore called the meeting to order at 10:00AM and took roll call.

Pledge of Allegiance

Lange made a motion to approve the agenda, seconded by Wilson.

Wilson made a motion to approve June 24, 2025, Regular Meeting Minutes, seconded by Lange.

Lange made a motion to approve July 3, 2025, payroll, seconded by Wilson.

Lange made a motion to approve July 8, 2025, claim set, seconded by Wilson.

No public comments on agenda items.

Engineer Dillon Davenport reported the following:

The Secondary Road Shop had a lighting audit completed and it has been determined that all new LED lights will be installed.

The cost of the project for the county after Alliant rebates is \$14,449 with a 4.4-year payback.

The two (2) roadside mowers are working through the motor grader districts currently.

The culvert crew is working on placing the rail tank car on 40<sup>th</sup> Street south of Highway 65.

Durapatcher is scheduled to be run next week but they are still trying to secure some washed chips for the projects.

The contractor has not signed the culvert lining contract yet. Davenport is not allowed to reach out to the contractor until the contract is signed.

The preconstruction meeting is scheduled for next Monday, July 14th for the 245<sup>th</sup> Street bridge project. The late date to start the project is July 20<sup>th</sup>. The road will be closed during the project.

Lange made a motion to approve Capital Asset addition for a 2006 International dump truck with a plow purchased by Secondary Roads from the Iowa DOT for \$18,000 with a 6-year useful life, seconded by Wilson.

### Monthly Department Reports:

Kellie Anderson, Wayne County Development mentioned there is a chamber meeting today at noon. The First Thursday Coffee is scheduled for this Thursday, July 10<sup>th</sup> at 7:30AM at her office due to the holiday last week.

Lange made a motion to approve the Recorder's June report, seconded by Wilson. Deposits totaled \$6,670.60.

Lange made a motion to approve the Recorder's Quarterly Report, seconded by Wilson. Deposits totaled \$16,961.89.

### Supervisor's meetings update:

Lange had no meetings to report on. He is working with the County Attorney, Al Wilson to draft an agreement for the Cinder Path with the Iowa DNR. He is hoping to present the agreement at the next meeting.

Wilson attended the 10-15 Transit meeting; there is nothing new to report.

Moore attended the New Venture Advisory Board meeting. Director Halie Spidle is looking to install new floor covering at the facility. Moore will attend a Wayne, Ringgold, & Decatur (WRD) Landfill meeting tomorrow. The new cell construction should begin this week if the weather permits. October 31<sup>st</sup>, 2025 is the target completion date. Moore will be attending a cemetery mapping committee meeting to get an update project after the Board of Supervisor's meeting today.

**Discussion item:** The master matrix for Gerald Lynch construction application has been reviewed and action will be taken at the next Board of Supervisor's meeting whether to approve or disapprove the construction. Public notice has been given of the application. No comments for or against the application have been filed with the Auditor's office.

Auditor Dooley also mentioned that the amount paid to township clerks and trustees for meetings attended in FY26 need to be set at the next meeting.

Nichole Moore, Director of the Chariton Valley Planning and Development, emailed information pertaining to solar and wind turbines ordinances. Supervisors do not want to infringe upon property owner's rights, but they do want to ensure that proper setback limits are set and that county road infrastructure is protected. Auditor Dooley will forward the documents to Engineer Davenport for his review and then will send them to County Attorney, Al Wilson for him to draft an ordinance to be considered.
