A regular meeting of the Wayne County Board of Supervisors was held on the 5th day of August 2025, at the Wayne County Courthouse in the Lower-Level Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present- Chris Moore, Todd Wilson, and Lance Lange members of the Board. Also in attendance: Dr. Joel Wells, Don Seams, Stacy Gibbs, Mendy Middlebrook, Kellie Anderson, Amanda Cooper, Dillon Davenport, and Michelle Dooley.

Unless otherwise noted, all motions are approved unanimously by all Board members present.

Moore called the meeting to order at 10:00AM and took roll call.

Pledge of Allegiance

Lange made a motion to approve the agenda, seconded by Wilson.

Wilson made a motion to approve July 22, 2025, Regular Meeting Minutes, seconded by Lange.

Lange made a motion to approve August 1, 2025, payroll, seconded by Wilson.

Lange made a motion to approve August 5, 2025, claim set, seconded by Wilson.

No public comments on agenda items.

Stacy Gibbs, City of Corydon Administrator, was present to ask the Board of Supervisors if they would be interested in being gifted parcel# 07190A251008 which sits beside parcel# 07190A251007. The Board of Supervisors are interested in having the parcel deed over to the county once the City of Corydon works with their legal counsel, Verle Norris, to move forward with the process.

Moore made a motion to appoint Mark Hewitt to the Veteran Affairs Commission, seconded by Lange.

Lange made a motion to accept the Treasurer's Semi-Annual Report for January – June 2025, seconded by Wilson.

Engineer Dillon Davenport reported the following:

Durapatcher is working on main county highways and then will move to the Old Highway 2(West)

Road crew is mowing roadside shoulders and ditches, as well as blading the rock roads and hauling rock.

The contractor for the bridge on 245th St. is running a little bit behind schedule. Some demo work has begun.

Culvert lining project is still scheduled to begin this week on S40 & J46. The road will be open for traffic but only one lane of traffic with a pilot car.

Davenport submitted a bridge project for a Bridge Improvement Program grant. This is a two-step approval process, 1st state level consideration then 2nd federal level consideration before being approved.

Moore gave the 1st Reading of Ordinance#204 Amendment Proposal:

IV Permit Procedures:

- Types of systems to be installed will be determined by the Wayne County Sanitarian and be approved in advance of construction beginning.
- j) Types of septic tanks will be determined by the Wayne County Sanitarian with the first preference being a cement tank and must be approved in advance of construction beginning.

Lange accepted and approved the 1st reading of Ordinance#204 Amendment, seconded by Wilson.

Lange made a motion to approve the county to participate in the new National Opioids Settlement reached with Purdue, seconded by Wilson.

Moore made a motion to approve Todd Wilson as the authorized signatory for opioid settlements, seconded by Lange.

Lange made a motion to approve Resolution 26-03, seconded by Wilson.

Department Monthly Updates: Kellie Anderson, Wayne County Development reminded everyone of 1st Thursday Coffee on August 7th at their office @ 7:30AM. Everyone is invited.

Moore mentioned that Assessor Brandon Carpenter is learning how to map the county cemeteries and should reduce the need from outside vendors.

Supervisor's meetings update:

Lange had nothing to report.

Wilson attended a Southern Iowa Response Group meeting. They are reviewing 28E agreements and compiling a list of equipment that counties own. He also attended the 10-15 Transit meeting. Milestone has paid 80% of what they owed the 10-15 Transit. 10-15 Transit is looking into new agreement with Milestone which will require payments to be made upfront. Wilson also attended the Southern Iowa Workforce Development Area meeting and it has been determined that they will merge with the Mississippi Valley Area.

Moore attended an EMS meeting. Bill Byrns has submitted his retirement letter effective November 5, 2025. The EMS Commission has determined that the position will be part-time (21-32 hours per week). They will be advertising for this position in the coming month.

Discussion items: Moore would like further discussion on the duties of E911 position.

Public Comments: Dr Joel Wells discussed his concerns regarding the mushy conditions of Old Hwy 2 (West) and if the best approach is to try to repair or replace. Engineer Davenport expressed that replacing the road or section of the road is probably not an option but did confirm that the durapatch crew would work on the road before winter.
