

Wayne County Board of Supervisors

A regular meeting of the Wayne County Board of Supervisors was held on the 28th day of October 2025, at the Wayne County Courthouse in the Lower-Level Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present- Chris Moore, Todd Wilson, and Lance Lange members of the Board. Also in attendance: Dan Carpenter, Dillon Davenport, Kellie Anderson, Becky Maxwell and Michelle Dooley.

Unless otherwise noted, all motions are approved unanimously by all Board members present.

Moore called the meeting to order at 10:00AM and took roll call.

Pledge of Allegiance

Wilson made a motion to approve the agenda with two additions- Appoint Civil Service Commissioner and Capital Asset Adjustment, seconded by Lange.

Lange made a motion to approve October 14, 2025, Regular Meeting Minutes, seconded by Wilson.

Wilson made a motion to approve October 24, 2025, payroll, seconded by Lange.

Lange made a motion to approve October 24, 2025, claim set for First Interstate Bank Credit Card Payments, seconded by Wilson.

Wilson made a motion to approve October 28, 2025, claim set, seconded by Lange.

No public comments on agenda items.

Engineer Dillon Davenport reported the following:

Durapatcher crew is working on S60 north of Seymour to get prepared for the concrete overlay project next spring.

Culvert crew is working on a large tank car culvert replacement on Cedar Road northwest of Lineville.

Bridge contractor on 245th Street is scheduled to pour concrete deck around Thanksgiving or 1st week of December. Hopefully, the bridge will be on for traffic around Christmas. Reminder that this bridge is 100% Federal Funding but due to road classification the county will pay contractor and then the State will reimburse.

The tank car culvert on Ohio Rd is scheduled to be replaced the Summer of 2026.

Lange made a motion to table advertising for New Venture Administrator until the next meeting, seconded by Wilson.

Wilson made a motion to request an in-depth audit of New Venture Group Home as part of the FY25 County Audit, seconded by Lange.

Wilson made a motion to reinstate the Compensation Board for setting a salary recommendation for elected officials for FY27 which begins July 1, 2025, seconded by Lange.

Wilson made a motion to appoint Mike Lewis, to fill the vacancy created by John Sellers Jr's passing, seconded by Lange.

Lange made a motion to approve the capital asset addition adjustment for the Sheriff's Building, seconded by Wilson. The capital asset amount was adjusted from \$149,826.92 to \$129,015.70.

Department Monthly Updates:

Wayne County Development Director, Kellie Anderson reminded everyone of the First Thursday Coffee to be held at their office starting at 7:30AM.

Supervisor's meetings update:

Wilson had no scheduled meetings to report on.

Lange attended the SCICAP meeting. Lange expressed concern that the Headstart Program will have to shut down on November 15th because they will be out of Federal Funding if the shutdown continues.

Wilson attended the WRD Landfill meeting and reported that the liner for the new cells should be installed this week.

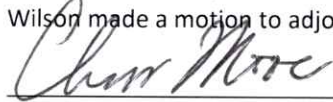

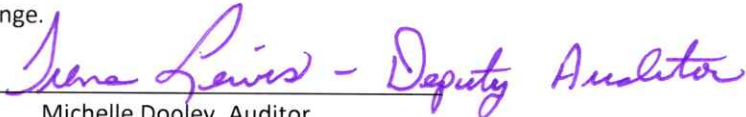
