Wayne County Board of Supervisors

A regular meeting of the Wayne County Board of Supervisors was held on the 10th day of November 2025, at the Wayne County Courthouse in the Lower-Level Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present- Chris Moore, Todd Wilson, and Lance Lange members of the Board. Also in attendance: Robert Zeigler, Kellie Anderson, Dan Capenter, Dillon Davenport, Don Seams, Chase Clark, Becky Maxwell, Kenzie Miner, Tiena Lewis, and Michelle Dooley.

Unless otherwise noted, all motions are approved unanimously by all Board members present.

Moore called the meeting to order at 10:00AM and took roll call. Pledge of Allegiance

Lange made a motion to approve the agenda seconded by Wilson.

Wilson made a motion to approve Oct.28, 2025, Regular Meeting Minutes, seconded by Lange.

Lange made a motion to approve November 7, 2025, payroll, seconded by Wilson.

Wilson made a motion to approve November 10, 2025, claim set, seconded by Lange.

No public comments on agenda items.

Engineer Dillon Davenport reported the following:

The surface prep on S60 is complete for the winter but may need to have some additional work done in the spring before overlay begins. Crews are patching on old highway 2 east of Corydon. Crews have been mowing fence-to-fence on the payment and have 75% of this done. After they have the fence-to-fence payment mowing done, they will move to gavels if time permits. Crews are getting the plow truck ready. The Lineville Railroad tank project is huge and still has a lot of work to do but the work is going well. It is estimated that there is at least one month of work left. The 245th street bridge replacement project is moving along but there is not much new to report. The anticipated opening of the bridge is around Christmas or the first of the year.

Lange made a motion to approve RESOLUTION FOR ROAD VACTION PUBLIC HEARING, Resolution 26-08 as follows, seconded by Wilson.

WHEREAS, a request has been filed with the Wayne County Engineer asking that action be taken to vacate and close a section of Wayne County Secondary Road, described as follows:

That portion of 190th Street, established June 6th, 1876 (See Road Record #486), beginning on the south line of the present right-of-way of Liberty Road, in the SW1/4 of Section 19, T69N, R20W, thence running south to the south line of said Section 19.

NOW, THEREFORE BE IT RESOLVED that a hearing on the proposed vacation will be held in the Conference Room, Wayne County Courthouse, Corydon, Iowa 50060, at 10:00 on Tuesday, November 25, 2025 in accordance with Iowa Code Chapter 306.

Lange made a motion to approve the City of Seymour tax abatement for past, present and future taxes, penalties, interest, and special assessment for parcel # 12140G475005, seconded by Wilson.

After some discussion about the New Venture administrator, Wilson made the motion to table advertising for the New Venture Administrator, seconded by Lange.

Lange made the motion to adjourn the regular meeting at 10:14 a.m. to go into closed session. Lange made the motion to re-open the regular meeting at 10:30 a.m., seconded by Wilson.

Lange made the motion to lower the IT Director's salary to \$63,000 annually down from 79,186.26 effective November 2, 2025, seconded by Wilson.

Moore made the motion to appoint Dennis St. Lawerence and Eric Couchman as representatives for the Board of Supervisors to the Compensation Board, seconded by Lange.

Lange made a motion to table the legal counsel for lawsuit filed against the Board of Supervisors, seconded by Wilson.

Lange made the motion to allocate \$1,000.00 to the Seymour Food Pantry after receiving their donation request and to put this. on the Nov. 10th claim set, Wilson seconded.

Department Monthly Updates:

Kellie Anderson, Wayne County Development reminded everyone of the Development meeting on Nov. 18th, 2025 @ 8:00 a.m. and the Chamber meeting at 12:00 p.m. Kellie also said that they hope to have the first Blessing Box, which was donated by MDL Insurance, put up at the LandGuys office this week and that it is the hope to have Blessing Boxes in all of the towns in Wayne County in the future. The Chamber is hoping to do a lighted parade on Dec. 13th, 2025, and will be talking to each business so that the square is lit up for the holidays. Dooley stated that we were going to be ordering lights for the courtyard area and that she had already spoken with Aaron about him installing the lights.

Lange made a motion to approve Recorder's October monthly report, seconded by Wilson. Deposits were \$5,465.76. Lange made a motion to approve the Public Health October monthly report, seconded by Wilson. Deposits were\$45,775.00.

Supervisor's meetings update:

Lange reported the Chariton Valley meeting that was scheduled got postponed. Lange attended the emergency South-Central lowa Community Action Program (SCICAP) meeting where they approved a one-time exemption for employees to apply for unemployment due to the government shut down and lack of funds beyond Nov. 15th, 2025, without using all their accrued vacation before applying for unemployment.

Dooley stated the City/School Election had gone well and that 731 voters cast a ballot.
