

## Wayne County Board of Supervisors

A regular meeting of the Wayne County Board of Supervisors was held on the 25th day of November 2025, at the Wayne County Courthouse in the Lower-Level Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present- Chris Moore, Todd Wilson, and Lance Lange members of the Board. Also in attendance: Dan Carpenter, Dillon Davenport, Don Seams, Kenzie Miner, Tiena Lewis, and Joella Perry who arrived at meeting at 10:12 A.M.

**Unless otherwise noted, all motions are approved unanimously by all Board members present.**

Moore called the meeting to order at 10:05 AM and took roll call.  
Pledge of Allegiance

Lange made a motion to approve the agenda, seconded by Wilson.

Lange made a motion to approve Nov. 10<sup>th</sup>, 2025, Regular Meeting Minutes, seconded by Wilson.

Wilson made a motion to approve the Nov. 12<sup>th</sup> 1<sup>st</sup> Tier Canvass Minutes, seconded by Lange.

Wilson made a motion to approve the 2<sup>nd</sup> Tier Canvass and Special Meeting Minutes, seconded by Lange.

Lange made a motion to approve November 21, 2025, payroll, seconded by Wilson.

Wilson made a motion to approve November 25, 2025, claim set, seconded by Lange.

No public comments on agenda items.

Lange made a motion to open the public hearing for road vacation at 10:08 a.m- Resolution # 26-08. The board asked if anyone had heard any opposition to the road vacation. There being no known opposition to the road vacation, Lange made a motion to close the public hearing for road vacation at 10:08 A.M.

Engineer Dillon Davenport reported the following:

All adjacent landowners of the road vacation had been notified by certified mail, and no comments had been heard from landowners or tents. The Dura patching is done for this year. Routine blading and preparation of the snowplows are being done at the present time. The Lineville RR tank project is substantially complete and if the weather goes bad this weekend the road could be rocked so that the road used with the remaining work to be completed in the spring. The 245<sup>th</sup> street contract bridge replacement project is taking a little longer than expected. The updated opening of the bridge could be the first or second week of Jan. 2026.

Lange made a motion to approve the Capital Asset addition of the 2023 Schulte Rotary Cutter valued at 28,000.00 and with a seven-year useful life, seconded by Wilson.

Lange made a motion to approve Resolution to Vacate a County Road (No. 26-09), Wilson seconded. Resolution No. 216-09 reads as follows:

WHEREAS, A public hearing was conducted on November 25, 2025, following publication and service of notice as required by law on the proposed vacation and closure of a portion of Wayne County Secondary Road, described as follows:

That portion of 190<sup>th</sup> Street, established June 6<sup>th</sup>, 1876 (See Road Record # 486), beginning on the south line of the present right-of-way of Liberty Road, in the SW1/4 of Section 19, T69N, R20W, thence running south to the south line of said Section 19.

WHEREAS, no objections have been received, either in writing or by persons present.

NOW THEREFORE BE IT RESOLVED by the Wayne County Board of Supervisors that the subject section of road be ordered vacated and closed.

That portion of 190<sup>th</sup> Street, established June 6<sup>th</sup>, 1876 (See Road Record # 486), beginning on the south line of the present right-of-way of Liberty Road, in the SW1/4 of Section 19, T69N, R20W, thence running south to the south line of said Section 19.

WHEREAS, Objections have been received by persons present regarding lack of access to their properties, if this entire segment is vacated.

NOW THEREFORE BE IT RESOLVED by the Wayne County Board of Supervisors that the section of this road from that portion of 190<sup>th</sup> Street, established June 6<sup>th</sup>, 1876 (See Road Record # 486), beginning on the south line of the present right-of-way of Liberty Road, in the SW1/14 of Section 19, T69N, R20W thence running south to the south line of said Section 19, be order vacated and closed.

Wilson made a motion to approve the sale of the bridge, which is located on the vacated and closed road, to the landowners (Christopher and Kara Carr), Lange seconded.

Wilson made a motion to approve Anthony Farnher to fill the vacancy on the Veteran Affairs Commissioner, seconded by Lange.

After some discussion, Moore approved a motion to table the Family Crisis Center funding allocation request and to appoint Lange as the contact to get more information on services provided, Wilson seconded.

Lange made a motion to approve the FY25 GAAP Annual Financial Report, seconded by Wilson.

Lange made the motion to approve the certification of the Cost Allocation Plan, seconded by Wilson.

Lots were drawn by the Board of Supervisors for the City of Seymour city council member since one of the write-in winners submitted a letter of resignation of his newly elected office to the City Clerk. The winner of the drawing was Sheryl Dotts.

Wilson made a motion to approve the Sheriff's Office monthly report, seconded by Lange. Deposits were in the amount of \$31,072.31.

Lange made a motion to approve the Clerk of Court monthly report, seconded by Wilson. Deposits were in the amount of \$659.79.

**Supervisor's meetings update:**

Lange attended the conservation board meeting and reported that they had voted on getting a time clock for employees. He also said Naturalist had served 804 people last month and reported that Trunk or Treat at Bob White on Oct. 25, 2025, had over 100 people to participate.

Wilson reported that he had attended a DECAP meeting and stated DECAP is on schedule to end services on June 2026. He attended a 10-15 transit meeting. He will be attending a special Eastern Iowa Work Force Meeting. There are concerns about liability wording issues with the agreement that was signed. He also attended the ISAC public tour.

Moore attended Public Health meeting. It was voted on at the Public Health meeting to spend all of the donation money that was received in a year plus all but one percent of the interest of the foundation money every year to go towards any future expansion to Meals on Wheels, other meal programs for people in the rural area, and possibly adding a another food pantry at the Public Health. Moore thought that this could be approximately \$5,000 to \$10,000 a year to be spend on these programs. Moore said that he had not been able to get an update on Heart of Iowa but will contact our County Attorney to see if he has any update on the liability.

**Discussion Items: None**

**Public Comments:** It was asked if Ottumwa was the closest location for Family Crisis services. Lange and Moore answered that it was regionalized and Ottumwa was our region.

Lange made the motion to adjourn at 10:44 a.m., seconded by Wilson.
