

Wayne County Board of Supervisors

A regular meeting of the Wayne County Board of Supervisors was held on the 23rd day of December 2025, at the Wayne County Courthouse in the Lower-Level Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present- Chris Moore, Todd Wilson, and Lance Lange members of the Board. Also in attendance: Dan Carpenter, Dillon Davenport, Don Seams, Kenzie Miner, and Tiana Lewis.

Unless otherwise noted, all motions are approved unanimously by all Board members present.

Moore called the meeting to order at 10:01 AM and took roll call.

Pledge of Allegiance

Lange made a motion to approve the agenda as presented, Wilson seconded.

Wilson made a motion to approve the corrected Nov. 25, 2025, regular meeting minutes, Lange seconded.

Wilson made a motion to approve Dec. 9, 2025, regular meeting minutes, Lange seconded.

Lange made a motion to approve Dec. 19, 2025, payroll, Wilson seconded.

Wilson made a motion to approve Dec. 23, 2025, claim set, Lange seconded.

Public Comment: none

Engineer Update: Dillon stated that the Lineville RR tank car project, except for seeding to be done next spring, was complete. They are starting to rebuild right away fencing. Dillon also stated a new tank car was ordered for the work on Ohio NE of Corydon for \$21,000.00. They will start on the dirt work, but will have to see how much they get done this winter. They are continuing to mow the fence-to-fence pavements and should be done in a couple of days. They will start to mow the major gravel roads next. Dillon told the board that the deck to the 245th Street Bridge replacement was poured last Wednesday. Dillon stated that he was pleased with the lower bid on the S60 PCC overlay project.

Dillon presented: Resolution 26-11:

WHEREAS, the Board of Supervisors, hereafter referred to as "the Board", believes the project STP-S-C093(98)--5E-93, hereafter referred to as "the project" is in the best interest of Wayne County, Iowa, and the residents thereof. The project is defined as PCC Overlay on S60, from Highway 2 south 4.1 miles to North Street; and

WHEREAS, the Board has sought appropriate professional guidance for the concept and planning for the project and followed the steps as required by the Code of Iowa for notifications, hearings, and bidding/letting; and

WHEREAS, The Board finds this resolution appropriate and necessary to protect, preserve, and improve the rights, privileges, property, peace, safety, health, welfare, comfort, and convenience of Wayne County and its citizens, all as provided for in and permitted by section 331.301 of the Code of Iowa; and

IT IS THEREFORE RESOLVED by Board to accept the bid from Manatt's Inc. in the amount of \$3,206,212.94 and awards the associated contract(s) to the same;

BE IT FURTHER RESOLVED that all other resolutions or parts of resolutions in conflict with this resolution are hereby repealed. If any part of this resolution is adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the resolution or action of The Board as a whole or any part thereof not adjudged invalid or unconstitutional. This resolution shall be in full force and effect from and after the date of its approval as provided by law; and

BE IT FURTHER RESOLVED by the Board of Supervisors of Wayne County, Iowa, that after receiving the necessary contract documents, including but not limited to, the contractor's bond and certificate of insurance, Dillon Davenport, the County Engineer for Wayne County, Iowa, be and is hereby designated, authorized, and empowered on behalf of the Board of Supervisors of said County to execute the contracts in connection with the afore awarded construction project let through the DOT for this county.

Lange made a motion to approve Resolution # 26-11 to accept the bid from Manatt's Inc. for the PCC overlay on S60, Wilson seconded.

Dillon presented: Resolution 26-10:

WHEREAS, the Board of Supervisors, hereafter referred to as "the Board", believes the project FM-C093(104)--55-93, hereafter referred to as "the project" is in the best interest of Wayne County, Iowa, and the residents thereof. The project is defined as Pavement Markings on Various FM Routes, County Wide; and

WHEREAS, the Board has sought appropriate professional guidance for the concept and planning for the project and followed the steps as required by the Code of Iowa for notifications, hearings, and bidding/letting; and

WHEREAS, The Board finds this resolution appropriate and necessary to protect, preserve, and improve the rights, privileges, property, peace, safety, health, welfare, comfort, and convenience of Wayne County and its citizens, all as provided for in and permitted by section 331.301 of the Code of Iowa; and

IT IS THEREFORE RESOLVED by Board to accept the bid from Proline Striping, Inc. in the amount of \$40,742.49 and awards the associated contract(s) to the same;

BE IT FURTHER RESOLVED that all other resolutions or parts of resolutions in conflict with this resolution are hereby repealed. If any part of this resolution is adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the resolution or action of The Board as a whole or any part thereof not adjudged invalid or unconstitutional. This resolution shall be in full force and effect from and after the date of its approval as provided by law; and

BE IT FURTHER RESOLVED by the Board of Supervisors of Wayne County, Iowa, that after receiving the necessary contract documents, including but not limited to, the contractor's bond and certificate of insurance, Dillon Davenport, the County Engineer for Wayne County, Iowa, be and is hereby designated, authorized, and empowered on behalf of the Board of Supervisors of said County to execute the contracts in connection with the afore awarded construction project let through the DOT for this county.

Wilson made a motion to approve Resolution # 26-10 to accept the bid from Proline Striping for county wide road striping, Lange seconded.

After some discussion, Lange made a motion to table the opioid sponsored awareness (Tall Cop) for the schools for a month until more information could be obtained, Wilson seconded.

Lange made a motion to pay the SAM claim for cemetery mapping in the amount of \$1462.50, Wilson seconded.

Lange made a motion to move \$10,000.00 into a budget line item for the cemetery project, Wilson seconded.

Lange made a motion to cancel the Precinct Atlas agreement, Wilson seconded.

Lange made a motion to approve the deposits from the Recorder's Office in the amount of \$5,093.59, Wilson seconded.

Wilson made a motion to approve the deposits from the Sheriff's Office in the amount of \$23,989.19, Lange seconded.

Supervisor's meetings update: Moore and Lange didn't have any meetings that they attended. Wilson attended the Miles Stone meeting, a TAC Meeting where the content of the long-range contract, that Sec. Rds. uses, was reviewed, a Southern Iowa Crime Commission-(SIACC) meeting where budgets for next year were discussed. Moore gave an update on the County lawsuit.




Moore made a motion to adjourn the meeting at 10:30 AM, seconded by Wilson.
