

## Wayne County Board of Supervisors (Correction)

A regular meeting of the Wayne County Board of Supervisors was held on the 6th day of January 2026, at the Wayne County Courthouse in the Lower-Level Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present- Chris Moore, Todd Wilson, and Lance Lange members of the Board. Also in attendance: Sheriff Keith Davis, Kellie Anderson, Dan Carpenter, Dillon Davenport, Don Seams, Kenzie Miner, and Michelle Dooley.

**Unless otherwise noted, all motions are approved unanimously by all Board members present.**

Moore called the meeting to order at 10:00AM and took roll call.

**Pledge of Allegiance**

Lange made a motion to approve the agenda seconded by Wilson.

Lange made a motion to approve December 23, 2025, Regular Meeting Minutes, seconded by Wilson.

Wilson made a motion to approve January 2, 2026, Organizational Meeting Minutes, seconded by Lange.

Lange made a motion to approve January 2, 2026, payroll, seconded by Wilson.

Wilson made a motion to approve January 6, 2026, claim set, seconded by Lange.

No public comments on agenda items.

Engineer Dillon Davenport reported the following:

Culvert is done on Cedar Rd northeast of Lineville except for seeding in the spring.

Culvert crew will be moving to Ohio Rd Northeast of Corydon next.

No updates on the two contracts approved for concrete overlay north of Seymour and the county-wide central line striping project.

Bridge project of 25<sup>th</sup> St is progressing slowly.

Compensation Board met on Monday, December 29<sup>th</sup> to determine the FY27 salary recommendations for elected officials. Their increase recommendation was Supervisors 4.86%, County Attorney 9.29%, Auditor, Recorder and Treasurer 4.86% and County Sheriff 15.29%.

Lance made a motion to approve 3% increase for Supervisors, Attorney, Auditor, Recorder & Treasurer and to set a salary of \$101,500 for the Sheriff, seconded by Wilson. Moore voted "nay". Motion carried and established Resolution 26-19.

**A Resolution pertaining to the salary recommendations made by the Wayne County Compensation Commission for the Elected Officials and Deputies**

We, the Wayne County Board of Supervisors reinstated the Compensation Board for FY27 Salary Increase Recommendations. The Compensation Board met on December 29, 2025. The Wayne County Compensation Commission recommended the following increases for each Elected Official for the fiscal year beginning July 1, 2026.

Middlebrook's work week will be split; 16 hours to New Venture, 16 hours to General Relief and 8 hours to Veteran Affairs. Moore approved Public Health Staff to code 5 hours/pp to New Venture for billing process, seconded by Wilson. Lange voted "Nay". Motion Carried


