Call to Order

The meeting was called to order by Wells at 9:00 am.

Approval of Agenda

McCart motioned to approve the agenda. Motion seconded by McCullough. All in favor. Motion passes unanimously.

Approval of Minutes of March 17, 2025

Program Updates

I-Smile – Angie Pettit – Updates for Wayne County. They are doing dental audits in schools for the Board of Health. They go twice a year for preschool and head start. Parents must fill out consent for their child to get checked. They also do the I-Smile at school program which is dental sealant program. They provided services for 2nd to 5th graders. Angie handed out report cards for Wayne County which included Corydon, Seymour and Humeston.

Quitline – Decatur County covers Wayne County for Quitline. They hand out tear tabs and have had a couple meetings in Wayne County.

Environmental Health Update

Daily Log – Board reviewed.

Financial Report – Amended the budget last week. Dave put in for more money in mileage.

Fee Policy- Change the fee policy to reflect itemized lab testing. DeVore motioned to change the fee policy to reflect itemized lab testing cost. The motion was seconded by McCart. All in favor. Motion passes unanimously. Dave will send a copy to Dr. Wells to sign off on.

Financial Report – Board reviewed.

SANE Training – S. Moore was approached to be a SANE Nurse. Training would be 40 hours, and she would have to do an exam. There is a scholarship to pay for the class. Whitney made a motion to approve S. Moore to go through training for the SANE Nursing program. The motion was seconded by Housh. All in favor. Motion passed unanimously.

Flooring Update – WCPH was awarded a \$3000 grant from the foundation and a \$1500 grant from Redeemed. There will be around \$1500 left to pay, that money can come from the Foundation money.

Window Bid – Board went over window bids. S. Moore suggests putting in opening windows versus closed windows. S. Moore will get clarification of the bid and email all board members. McCart made a motion to install windows pending clarification of the bid. The motion was seconded by DeVore. All in favor. Motion passed unanimously.

Other Business

S. Moore did get her CPR Instructor certification. She will be able to teach CPR classes.
