Precinct A -01 – Polling Location is the Civic Center, Allerton, Iowa  
Those located in the Cities of Allerton, Clio and Lineville, Townships of Clinton, Grand River, Howard, Jackson, Jefferson and Warren will vote at this location.

Precinct C-02 – Polling Location is the Basement Meeting Room of the Wayne County Courthouse, Corydon, Iowa. Those located in the City of Corydon, Township of Benton and Corydon will vote at this Location.

Precinct H-03 – Polling Location is the Community Building, Humeston, Iowa
