Wayne County Board of Supervisors

Regular scheduled meeting of the Wayne County Board of Supervisors was held on the 1st day of June 2021, in the Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were David Dotts, Tom Swearingin, Don Seams: members of the Board, Keith Davis, Randy Zerr, Aaron Hoelting, Jen Reed, Rhonda Bennett, Angie Horton, Sue Ruble and Michelle Dooley.

The Corydon Times Republican live streams Board of Supervisors regular session meetings on their facebook page.

Unless otherwise noted, all motions are approved unanimously by all Board members present.

Dotts called meeting to order at 9:00AM and took roll call.

Pledge of Allegiance

TSwearingin made motion to approve the June 1, 2021 agenda, seconded by Seams.

Seams made motion to approve May 17, 2021 minutes, seconded by TSwearingin.

TSwearingin made motion to approve May 28, 2021 payroll, seconded by Seams.

Seams made motion to approve June 1, 2021 claims, seconded by TSwearingin.

Thirteen sealed bids for the 2003 Chevy Impala were presented to the Supervisors and opened by TSwearingin. Seams made motion to accept the highest bid of \$3,000.00 from Gayle Wasson, seconded by TSwearingin. Seams also made motion to accept second highest bid from Jane Cooley for \$2,555.00 in case there are any issues with completing the sales with first highest bidder, seconded by TSwearingin.

Randy Zerr, County Engineer reported that he is still working on the 28E agreement with City of Corydon. He also gave an update on the calcium spots being applied.

Keith Davis, County Sheriff discussed his need to increase the salaries for his hourly jailers/dispatchers. He stated that he has submitted a five percent recommended increase earlier to Michelle but that due his struggle to retain employees he is considering increasing that percentage to be more competitive with surrounding counties, specifically Appanoose and Monroe counties. He will give it some more thought and get back to the board with his new increase recommendation. Davis talked about the Blue Bill that was passed by legislation regarding setting the Sheriff's salary and stated that may change how the Compensation Board sets the Sheriff's salary in the future. He also stated currently there are three Deputy Sheriff positions open, and he is working through the process to fill the positions.

Aaron Hoelting, Courthouse maintenance, presented a quote of \$6,772.00 from Excel to replace the number three compressor of the Trane unit on the Courthouse air conditioning system. Seams made motion to accept the quote and replace the compressor of the Trane unit, seconded by TSwearingin.

Joella Perry, Veteran Affair Administrator, gave an update on the signs for inside the courthouse. Perry reminded everyone of the Outreach Dinner being held on June 10, 2021 in Allerton. Meet and greet starts at 4PM and dinner will be served at 6PM.

Seams made motion authorizing Michelle Dooley, County Auditor to set up a Wayne County Health Insurance checking account at Great Western Bank per resolution 21-29 and to designate the County Auditor, County Deputy Auditor and County Treasurer or designee to be signors on the account, seconded by TSwearingin.

After some discussion, Seams made motion to rescind the Wayne County Covid-19 mask policy, seconded by TSwearingin.

Seams informed the rest of the Board that the Smart Board in the conference room was non-repairable due to parts not being available. Seams made motion for County Auditor to post the Smartboard on Facebook Market Place for best offer to try to get rid of it since Seams had contacted all the schools in Wayne County and no one wanted it, seconded by TSwearingin.

TSwearingin made motion to abate all taxes, interest, and penalties on record at this time and any future taxes for the City of Humeston Parcel # 01150E351005/01150E351006, seconded by Seams.

County Treasurer's Cash & Outstanding April Report was presented. TSwearingin made motion to accept the Treasurer's April Report, seconded by Seams.

The required Open Meeting Training/Open Meeting Law 101 from the Iowa Public Information Board was presented and read aloud by Dotts to all attendees of the meeting.

Discussion: Chris Furlin has completed the courtyard project and has done a good job filling in the holes. Seams also asked if Aaron Hoelting, Building & Ground Maintenance had followed up on painting the courthouse.

Supervisors Meetings:

TSwearingin attended 10-15 Transit meeting by phone. 10-15 Transit submitted legal action against the City of Ottumwa.

TSwearingin and Seams attended the Meal Site meeting. It was discussed at the meal site meeting that Wayne County might purchase the building for \$1.00 from the meal site committee. The Board of Public Health made a motion to seek Legal Counsel, to take action to purchase location at a later date.

Dotts attended the Wayne County Development meeting. It was decided at the meeting that Wayne County Development will hire Amber Rogers for one day a week to do Executive Director work. Wayne County Development will share Amber with the Wayne County Foundation and several other entities.

Seams attended an executive committee meeting for Iowa Workforce Development. Seams stated that several more meetings will be required due to a change in the budget as the committee has to sign off on the dollar amounts changes. Seam also stated he attended the CROSS-meeting Tuesday and that legislation passed law that Mental Health will be funded thru the State. The State will force us to start spending our reserve funds or it will be disbursed to other regions that are not financially stable if we are not under the required amount in the reserve account. Amy Sinclair and Joel Fry is invited to next month's Cross meeting. The meeting date will be set and published.

Public Comment: Sue Ruble was present to state her frustration with the lowa legislation. Ruble also shared her support for CDC recommendations requiring mask to be worn in public by individuals who are not vaccinated against COVID.
