

Wayne County Board of Supervisors

Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 9th day of August 2021, in the Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were David Dotts, Tom Swearingin, Don Seams members of the Board, Randy Zerr, Dan Carpenter, Robert Stanley, Bill Stanley, Zach Robinson, Marvin Robinson, Linda Dawson, Jen Reed, Rhonda Bennett, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their facebook page.

Unless otherwise noted, all motions are approved unanimously by all Board members present.

Dotts called meeting to order at 9:00 AM and took roll call.

Pledge of Allegiance

Swearingin made a motion to approve the August 9, 2021, agenda seconded by Seams.

Seams made a motion to approve July 26, 2021, minutes, seconded by Swearingin.

Swearingin made a motion to approve August 6, 2021, payroll, seconded by Seams.

Seams made a motion to approve August 9, 2021, claims, seconded by Swearingin.

No public comments regarding agenda items.

Seams made a motion to open the public hearing for the proposed vacation of 55th Street and Fremont Road, seconded by Swearingin. Robert & Bill Stanley spoke out against vacating 55th Street & Fremont because they are landowners, and their property would be landlocked if the Board of Supervisors approved the vacation. Zach & Marvin Robinson were present, and Zach spoke regarding his request for the vacation. His request started because the road has been closed for several years due to a low water crossing issue. Zach Robinson and Jared Dodson have tried to use some of their personal equipment to improve the low water crossing issue, but it is a mess. Robinson was not aware that the Stanleys would be landlocked, and he was not for vacating the road after learning the new information but wants the county to fix the road and make it useable again. Randy Zerr, County Engineer stated that the county would fix the low water crossing if landowners were willing to remove some fence and if the landowners would be responsible for replacing the fence after the project is completed. Robinson did not have any issues with removing or replacing fence. Zerr and Dan Carpenter spoke of their plans to remedy the situation and hopes to have the road fixed and reopened by the end of fall 2021. Seams made a motion to not vacate 55th Street and Fremont Road per the request, seconded by Swearingin.

Seams made a motion to close the public hearing for the proposed vacation of 55th Street and Fremont Road, seconded by Swearingin.

Linda Dawson requested to use the Courthouse Conference Room on August 24, 2021 @ 7PM for an educational Townhall meeting regarding the Convention of States Action specifically Article 5. Swearingin made a motion to approve Dawson's request, seconded by Seams. There will not be a charge for the use of the conference room since the purpose is not for profit.

Zerr, County Engineer also thanked the Board of Supervisors for signing the title page of the Medicine Creek Project. The Medicine Creek project is still on schedule as far as Zerr is aware of.

Yates and Yates gave a quote in January and April 2021 for replacing the West Courthouse Entry Glass and doors, the west interior doors of the foyer and the west doors on the 2nd floor landing area January and April of 2021. Those quotes were adjusted by \$500 per entrance per email from Mike Townsend with Yates and Yates. The new cost of the project is \$20,021. Seams made a motion approve the new quote and to move forward with the door project, seconded by Swearingin.

FY22 Capital Asset forms were presented for the new 2021 Ford F150 purchased by the Board of Supervisors to be used by Bill Byrns, EMA Coordinator and the new 2021 Chevy Tahoe purchased by the Sheriff's Office. Swearingin made a motion to approve the FY22 Capital Asset Additions, seconded by Seams.

The July 2021 Report for the Recorder's Office was presented. Their deposit for July was \$6,084.18. Seams made motion to accept and approve the Recorder's July Report, seconded by Swearingin.

Board of Supervisors discussed using part of the American Rescue Act Plan Funds for replacing the Courthouse Heating and Cooling System since it was a qualified expense dealing with air quality. Currently, Wayne County has requested their allocation but has not received their funding from the Federal Government. Dooley stated she has been in contact with the US Treasury and the deposit should very soon.

Swearingin had no meetings to report on.

Seams attended the CEO meeting for South-Central Iowa Workforce Development. Pathfinders will continue to provide services as the Fiscal Agent until July 2022. In April 2022, the Workforce Development Board will take bids for the Fiscal Agent service and bids will be taken for a single audit for the region. Seams also attended a County Rural Offices of Social Services (CROSS) meeting to discuss how to get fund balances spent down so that the region will not lose funding to the larger counties.

Dotts attended a South-Central Iowa Community Action Program (SCICAP) and they discussed budget items. Dotts also attended the 5th Judicial Committee and they discussed upcoming projects for the district.

Public Comments:

Linda Dawson also requested the Board of Supervisors to consider passing a resolution naming Wayne County as a 2nd Amendment Sanctuary County. Dawson stated several counties have passed a similar resolution and Sheriff Keith Davis is in support of the Resolution as well. Seams stated that it needs to be an agenda item on the August 23rd meeting for the Board to consider taking action.
