Wayne County Board of Supervisors

Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 4th day of October 2021, in the Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were David Dotts, Tom Swearingin, Don Seams members of the Board, David Rhodes, Bill Byrns, Randy Zerr, Aaron Hoelting Rhonda Bennett, Jen Reed and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their facebook page. **Unless otherwise noted, all motions are approved unanimously by all Board members present.**

Dotts called meeting to order at 9:00 AM and took roll call.

Pledge of Allegiance

Swearingin made a motion to approve the October 4, 2021, agenda, seconded by Seams.

Seams made a motion to approve September 20 & 21, 2021, minutes, seconded by Swearingin.

Swearingin made a motion to approve October 1, 2021, payroll, seconded by Seams.

Seams made a motion to approve October 4, 2021, claims, seconded by Swearingin.

No Public Comments regarding agenda items

Seams presented the proposal from Corey Metzger with Resource Consulting Engineers LLC for engineering services for the Courthouse HVAC system. Services provided will be:

- > Review existing building HVAC system & verification of distribution, zoning
- Load calculations
- > Ventilation calculations
- Review calculations based on County personnel
- Develop the report documentation

The scope of the job will be completed as soon as possible, and the cost is not to exceed \$4,000 unless additional services are requested.

Seams made a motion to accept and approve the Resource Consulting Engineers LLC proposal, seconded by Swearingin.

Randy Zerr, County Engineer, started with his deepest and sincerest condolences to the family of Pat Kelly. Pat was a motor grader operator for the past 16 years for the county and will be greatly missed.

Zerr reported the bid letting for Medicine Creek is still scheduled for November 16, 2021, with a spring start date. The contractor for the pavement stripping will start the project in the spring of 2022. The bridge crew is working on 150th Street bridge south of Highway 2 driving the piling. Then they plan on moving to the Sunny Slope bridge next. Zerr reported that FEMA has reached out to the state and they are wanting more calculations for the low water crossing project. Zerr is not sure why.

David Rhodes, County Sanitation, reported that he now has the Dodge Ram and asked the board what they would like to do with the 2010 Ford Explorer. The explorer has approximately 115,000 miles. Swearingin made a motion to put the 2010 Ford Explore up for public sealed bids, seconded by Seams.

Aaron Hoelting, Building and Grounds Maintenance, was present to discuss the Courthouse Security System. Hoelting presented bids from Grand River Mutual and Superior Cable. Swearingin made a motion to accept and approve Superior Cable/Electrical Contractor for \$6,668.53 for a new courthouse security camera system with 11 new cameras, seconded by Seams.

Chariton Valley Regional Housing Trust Fund is requesting the Board of Supervisors to set their pledge amount for FY23. The pledge amount is matched 4:1 and all funds stay in the county. Caleb Housh currently represents Wayne County on the Chariton Valley Regional Housing Trust Fund. This organization helps many individuals financially to make improvements their homes and enables individuals to stay in their home longer. Several other entities located in Wayne County as well as the cities contribute to the Housing Trust Fund. Dotts would like to encourage the other board members to increase the

pledge from the FY22 Pledge of \$7,500. Swearingin made the motion to approve \$10,000 pledge for FY23, seconded by Seams.

No Department/Office Reports were presented.

Supervisors Discussion: Seams stated that Public Health has 2 bids for solar energy for their new future location. Shelley Bickel, Wayne County Public Health Director is hoping to receive a total of 3 bids before making a decision. Swearingin recommended reaching out to Superior Cable because Mr. Talbot has expanded his business to include solar as well. Seams is hesitant to go with a company located outside of lowa, he hopes that the bid can be awarded to an lowa based company. Seams says that one thing to look at closely is the inverters that is used in the systems. Seams will work on getting more bids before making a decision. Dotts expressed the difficulty of making sure that the bids are comparable.

Supervisor meetings: All 3 Supervisors attended the Courthouse Security Meeting.

Swearingin attended Public Health Board Meeting and they completed evaluations for Shelley Bickel and David Rhodes. They discussed upcoming events and Covid updates. Swearingin attended 10-15 Transit meeting. 10-15 is having issues with some of their new buses. They have had a technician on site to look at the issues. They have finally gotten possession of a rental property that they own and will be working on making improvements there. Ridership is up from previous months and they are still fighting with the City of Ottumwa for the funding that is owed to them. Swearingin also attended the Conservation Board meeting; Kenny reported the dock is complete, the dozer dirt work is completed which covered approximately 4 acres of trees being removed and creating some new little islands within Medicine Creek. Over labor days camper numbers were a little soft but have several projects completed.

Dotts attended the South-Central Iowa Community Action Program (SCICAP) meeting. Everything is going very good there. They are looking at purchasing some land in Clarke County and building a new Head Start location with the funds the Governor is allocating to SCICAP.

Seams attended the South-Central Iowa Workforce Development Area (SCIWA) meeting where they hired an assistant Director. Seams also attended the South-Central Iowa Workforce Development Executive meeting and they approved the hiring of the new Assistant Director. Seams also discussed attending the County Rural Offices of Social Services (CROSS) meeting where they discussed the fund balance of the region. The state is taking over the Mental Health program and the region is concerned that they will be forced by the state to turn over their funds to other regions that are financially struggling. Therefore, the CROSS region is trying to spend down their fund balance for projects linked to mental health. One project that Seams mentioned was: Ringgold County is looking at in broadband for telehealth services. One of the members of the CROSS region recommended that the fund balance be split evenly between the 7 counties that make up the region and invest those funds locally to benefit mental health. Seams and Mendy Middlebrook is working to development a plan for Wayne County and asked the other board members to think of options that they felt might be needed in Wayne County. Swearingin asked more questions about investing in broadband for rural areas and Seams thought that Wayne County was sitting pretty good with broadband.

Public Comment: All the supervisors spoke of memories that they had with Pat Kelly and what a good friend and a good worker he was for Secondary Roads Department. And once again gave their condolences to Brenda and Pat's entire family.
