Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 28th day of December 2021, in the Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were David Dotts, Tom Swearingin, Don Seams members of the Board, Dan Carpenter, Rhonda Bennett, Jen Reed and Michelle Dooley. Mendy Middlebrook and Aaron Hoelting joined the meeting for the annual review.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their facebook page. Unless otherwise noted, all motions are approved unanimously by all Board members present.

Dotts called meeting to order at 9:04 AM and took roll call.

Seams made a motion to approve the December 28, 2021, agenda, seconded by Swearingin.

Rhonda Bennett requested that The Times Republican and New Era be named as the official county newspapers for 2022. The official county newspapers will be named during the January 3, 2022, meeting.

Dan Carpenter gave an update for Secondary Roads/Engineer's Office. The pilings have been driven for the Sunny Slope Bridge. Final plans have been received for the bridge on 105th Street. And they have met with the contractor for the Medicine Creek project and the target start date is January 3rd or 9th; weather permitting.

The Compensation Board met on Tuesday, December 21, 2021. They recommended 12% increase for the Sheriff and 8.67% increase for all other elected officials. The Board will set the increase after Department budgets have been submitted for FY23.

Swearingin made motion to approve abatement of all past, present, and future taxes, penalties, and fees for the City of Humeston for parcel # 01150A101006, seconded by Seams.

Wayne Community School District is calling for a special election held on Tuesday, March 1, 2022, to vote on three (3) public measures. Swearingin made motion to approve the special election, seconded by Seams.

Seams made motion to approve the capital asset addition for New Venture's Handicap Accessible 2021 Chrysler Voyager Van for \$64,110, seconded by Swearingin.

Seams made a motion to properly dispose of the old courthouse security system and to take bids for the two (2) older New Venture vans, seconded by Swearingin.

Dooley requested the Board to consider allowing the retirees of the county from the past five years and retirees going forward to continue membership benefit with The Prairie Trail Fitness Center. Prairie Trails Fitness Center has approved the request and there is no added expense to the county. Swearingin made motion to approve the membership benefit for county retirees to Prairie Trails Fitness Center, seconded by Seams.
