

## Wayne County Board of Supervisors

Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 10th day of January 2022, in the Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were David Dotts, Tom Swearingin, Don Seams members of the Board, Randy Zerr, Dan Carpenter, Rhonda Bennett, Jen Reed and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their facebook page.

**Unless otherwise noted, all motions are approved unanimously by all Board members present.**

Dotts called meeting to order at 9:02AM and took roll call.

Pledge of Allegiance

Seams made a motion to approve the January 10, 2022, agenda with the addition of approving January 6, 2022, Minutes, seconded by Swearingin.

Swearingin made motion to approve the January 3 & 6, 2022 minutes, seconded by Seams.

Seams made motion to approve the January 7, 2022, payroll, seconded by Swearingin.

Swearingin made motion to approve the January 10, 2022, claims, seconded by Seams.

No public comments regarding agenda items.

Dotts did the 2nd reading of Ordinance 2022-01 to eliminate the residency requirement for Wayne County Sheriff's Deputies and employees.

### **BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF WAYNE COUNTY, IOWA**

**SECTION 1 – PURPOSE.** The purpose of this ordinance is to eliminate the state residency requirement for Wayne County Sheriff's Deputies as required by the Iowa Law Enforcement Academy, Iowa Administrative Code 501-2.1(1).

**SECTION 2 – RESIDENCY REQUIREMENT ELIMINATED.** As of the effective date of this ordinance, Wayne County Sheriff's Deputies and employees will no longer be required to be residents of the State of Iowa.

**SECTION 3 – TIME AND DISTANCE REQUIREMENTS.** The Sheriff's Office shall assess the needs and demands of their department and shall establish a time and distance policy for the employees of their department.

**SECTION 4 – EFFECTIVE DATE.** This Ordinance shall be in full force and effect after its passage, approval and publication as provided by law.

Swearingin made motion to suspend the 3<sup>rd</sup> reading of Ordinance 2022-01, seconded by Seams.

Dotts read the 2nd Reading of Ordinance 01-03-22 setting the Precinct Boundaries.

An Ordinance retaining the Precinct boundaries and Precinct Names to be used for Election Purposes in Wayne County, Iowa.

**Whereas;** The Wayne County Board of Supervisors has drawn the voting precincts and boundaries, and;

**Whereas;** The Wayne County Board of Supervisors held public hearing on January 3, 2022 at 9:00AM in the Courthouse Basement Conference Room regarding precinct boundaries.

**Therefore;** The Wayne County Board of Supervisors adopts and approves the following voting precincts in Wayne County for all State and Federal Elections;

**Precinct A01 Allerton**

Includes the Cities of Allerton, Clio & Lineville and the Townships of Clinton, Grand River, Howard, Jackson, Jefferson & Warren.

**Precinct C02 Corydon**

Includes the City of Corydon and the Townships of Benton & Corydon.

**Precinct H03 Humeston**

Includes the Cities of Humeston & Millerton and the Townships of Clay, Richman, Union & Washington

**Precinct S04 Seymour**

Includes the Cities of Promise City & Seymour and the Townships of Monroe, South Fork, Walnut & Wright.

**Therefore:** The Wayne County Board of Supervisors approve and adopt the above-named precincts as listed on January 3, 2022 & January 10, 2022.

Seams made motion to approve the 2nd reading of ordinance 01-03-22, seconded by Swearingin.

Swearingin made motion to suspend the 3<sup>rd</sup> reading of ordinance 01-03-22, seconded by Seams.

County Engineer, Randy Zerr gave an update for the Secondary Roads Department.

Contractor for Medicine Creek Project will be work the week of January 17<sup>th</sup>.

Equipment/vehicles will be on Purple Wave in the Spring for sale.

There will be a job posting for the Secondary Road Department for general labor/operator soon.

Bob Jackson called requesting the county to vacate a road that runs North-South adjacent to his property. The only documents found dated back to the 90's and addressed the road being relocated to an East-West Road to allow access to public hunting.

Seams discussed the rumor of a road grader being parked down a level-B road and that the county was considering rocking the level-B road because of it. Seams made it very clear that it is not the practice of the county to rock level-B roads and it was not legal to use county equipment or taxpayer dollars for personal gain. Rocking that level B road would be a personal gain for two families living on that level-B road. He also stated that there are other residents in the county, that live down level-B roads, who are personally responsible for the cost of rocking their level-B roads . Seams also wanted to make sure the County Engineer Zerr was aware that there are other location options for parking the road grader when not in use. Seams attended the Promise City Council meeting and discussed the option of parking the road grader in Promise City in exchange for blading North Street. Seams stated that a new 28E agreement would need to be done between the county and the Promise City if this option is acted upon.

Seams made motion to approve the addition of 2 new motor graders (#17 & #19) and the removal of the trade-ins from the Capital Asset Listing, seconded by Swearingin. Dan Carpenter, Assistant Engineer stated that next year the county will qualify for a guaranteed buyback of motor graders being traded with Ziegler.

Seams made motion to approve the Mormon Trail CSD request for abatement of all past, present & future taxes, penalties, fees & interest in regard to parcel# 010J21200004 & 010J21200011, seconded by Swearingin.

Seams made motion to accept & approve the County Recorder's December Monthly report and her quarterly report, seconded by Swearingin. In December, deposits were \$8,668.28 and deposits for the quarter were \$20,201.37.

No discussion items.

Supervisor meetings:

Seams delivered Meals on Wheels with his wife and stated how appreciative the people are of those meals. He encourages anyone who are able, to help with delivering the Meals on Wheels. Seams also attended the Promise City Council meeting.

All Supervisors attended a special meeting at the First Christian Church and a Board Member led a tour of the facility. All Supervisors attended the Department Head/Elected official meeting.

Public Comments:

Michelle Dooley asked the Board to give clarification to why "Options for location of motor graders" was on the agenda. Seams thought that he explained why it was on the agenda, but Dooley went on to state "That it may not have been clear to the public and went on to state that the Board of Supervisors and the County Engineer made the decision to remove the blade operator from the blade for the Seymour area after hearing public concerns/issues in the Amish community around Seymour. Also some of the issues were discussed in a public meeting by Gene Mattly and the public should know that their concerns were heard, and action was taken. Now there is a new blade operator and the blade is now located down a level-B road that borders Appanoose County. Seams stated that when the public has concerns, he has a responsibility to pass the concerns on to the Engineer. Seams also stated that the lack of rock gets blamed on the road graders but the amount of rock put on the roads is up to the County Engineer. Seams and Dotts both stated that traffic count should be reviewed as the rock roads in that area are highly traveled. Seams stated that when he lived in the area there were 3 families on

his road and now there is 14 families. Seams stated that he was not involved in the Engineers decision to remove the blade operator but wants to be kept informed. Swearingin stated the Engineer never does anything big without the Boards blessing. Dooley thanked the Board for the clarification.


