

Wayne County Board of Supervisors

Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 4th day of April 2022, in the Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were David Dotts, Tom Swearingin members of the Board, Shelley Bickel, Randy Zerr, Dan Carpenter, Jen Sheston, Deidre Buttz, Charlotte VanFleet, Susan Moore, Marilyn Goughnour, Robert Michael, Leroy & Pat Perkins, Rhonda Bennett, Jen Reed and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page. **Unless otherwise noted, all motions are approved unanimously by all Board members present.**

Dotts called the meeting to order at 9:00AM and took roll call.

Pledge of Allegiance

Swearingin made motion to approve the April 4 , 2022 agenda, seconded by Dotts.

Swearingin made motion to approve the March 21, 2022, minutes, seconded by Dotts.

Swearingin made motion to approve the April 1, 2022, payroll, seconded by Dotts.

Swearingin made a motion to approve the April 4, 2022, claims, seconded by Dotts.

No public comments regarding agenda items.

Dotts began the meeting with reading a letter in support of the purchase of the First Christian Church facility submitted by Sherry Middlebrook for Wayne County Public Health.

Swearingin made a motion to open the public hearing regarding the purchase of the First Christian Church located in Corydon, Iowa at 9:07AM, seconded by Dotts.

Auditor Dooley reported no written or verbal comments for or against the purchase of the First Christian Church facility were filed with the Auditor's office.

No further discussion regarding the purchase of the real estate was made.

Swearingin made a motion to close the public hearing regarding the purchase of the First Christian Church at 9:08AM, seconded by Dotts.

Swearingin made the motion to approve the purchase agreement written and presented by County Attorney, Al Wilson, seconded by Dotts.

Marilyn Goughnour, Robert Michael and Leroy and Pat Perkins were present on behalf of the First Christian Church. They requested for time to review the purchase agreement before signing. The Board will honor their request and will wait to hear back from the church members.

Randy Zerr, County Engineer gave an update for Medicine Creek Project. Contractor has dropped in the shutoff gates leaving only a 3'x3' opening for the water to flow thru. Once the downstream work and backfill is completed the plug will be installed to finish the project. Jeff Boyd has reached out to the pavement striking contractor to determine a start date for that project. The bridge on Fillmore and 220th Street had to be closed per the DOT. Zerr reported that hopefully that replacement project can begin soon after the Amish School concludes for the summer but for now the Amish buggies are still allowed to pass over the bridge. The bid has been awarded for the bridge on Birch and they are working on scheduling a meeting with the contractor for the project. Also work will continue to be done on the low water crossing in the county. Zerr also followed up his email to the Board of Supervisors regarding his requested revisions of the contract. Dotts respond "No." Swearingin stated that he has seen the email from Zerr and he is ok with the Zerr's requested revisions. The revisions include the county will pay for Zerr's Missouri Engineering Licenses, changing the 60day written requirement to 30days if contract is terminated by either party, and waiving the requirement of Zerr to give written notice to the county if he is performing engineering services. Dotts stated that Seams was unable to attend today's meeting and that he was honoring Seams' request for a special meeting to be held on April 11th. Swearingin expressed his concern that a decision may not be reached before April 17th deadline.

Zerr requested Dotts and Dooley's signature on the IDOT Budget and 5-year plan that was emailed to the Board and discussed during the February 22nd meeting.

Swearingin approved the Recorder's March Report, seconded by Dotts. Their deposits for March were \$6,533.80. Swearingin approved the Recorder's Quarterly Report, seconded by Dotts. Their deposits for the 3rd Quarter were \$17,535.38.

No Discussion

Supervisor Meeting:

Swearingin attended a 1015 Transit meeting. They are currently short on drivers and their new buses are experiencing issues with the air ride system.

Dotts attended a SCICAP meeting, and they discussed financials.

Public comments: Shelley Bickel, Director of Wayne County Public Nursing thanked the Board for their commitment to Public Health and the purchase of a new facility. Swearingin and Dotts both thanked the church for their consideration and their willingness to sell their facility to Wayne County.
