Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 31st day of May 2022, in the Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were David Dotts, Tom Swearingin, Don Seams members of the Board, Sheriff Keith Davis, Deputy Sheriff Brandon Ward, Randy Zerr, Joella Perry, Aaron Hoelting, Ericka Graves, Jen Reed, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page. Unless otherwise noted, all motions are approved unanimously by all Board members present.

Dotts called the meeting to order at 9:03AM and took roll call.

Pledge of Allegiance

Swearingin made a motion to approve the May 31, 2022, agenda with the addition of Joella Perry, Veteran Affairs Director and appointing commissioner, seconded by Seams.

Seams made a motion to approve the May 16, 2022, minutes, seconded by Swearingin.

Swearingin made a motion to approve the May 27, 2022, payroll, seconded by Seams.

Seams made a motion to approve May 31, 2022, claim set, seconded by Swearingin.

No public comments regarding agenda items.

Dotts administered the Oath of Office to Deputy Sheriff, Brandon Ward.

Joella Perry requested that Terry Snow be re-appointed as Veteran Affair's Commissioner for another 3-year term effective June 1, 2022. Seams made the motion to re-appoint Terry Snow as VA Commissioner, seconded by Swearingin.

Randy Zerr, County Engineer gave an update for Medicine Creek Project. The contractor is working on the downstream erosion control. If the weather holds out for a couple of weeks, the project should be completed. The pavement striping contractor is scheduled to begin work Monday, June 13.

Situs Cultivation, LLC requested redemption for tax sale certificates for parcel # 130H20300005 certificate#2015-0507 & 01150A103005; certificate#2018-00704. Swearingin made the motion to approve full redemption of tax sale certificates, seconded by Seams.

The Board discussed with Aaron Hoelting; Courthouse & Yard Maintenance about the additional duties that he has taken on since the Wayne County Public Heath Department has moved to their new location at 105 N. Lafayette St. Corydon. Hoelting is putting in 5 hours a week at Public Health Facility. Seams made a motion to approve a \$5,000 salary increase effective immediately with no pay raise on July 1st, 2022, seconded by Swearingin.

Swearingin made motion to approve the allocation of \$1,000 to Humeston Swimming Pool and \$2,000 for the Prairie Trails Family Aquatic Center for swim lesson for FY22, seconded by Seams.

Auditor Dooley requested the Board move the Board of Supervisor Regular meeting for Monday, June 13 to Tuesday, June 14th. Swearingin made the motion to approve the next regular meeting to be held on Tuesday, June 14, 2022, seconded by Seams.

No Department/Office Reports presented.

No Discussion held.

Supervisor Meeting:

Dotts attended DECAT meeting. The local DECAT Board was out of funding for a program but the Clinton/Jackson DECAT Region allocated \$15,000 to the local region to continue program. Wayne County Housing Committee met and is addressing the housing issues. More will be shared in the future. Dotts attended the Veteran Affair Outreach program and there were 66 individuals in attendance.

Swearingin attended the first meeting for Wayne County Health Board in their new facility. They will be introducing some new programs in the coming months. Insulation in the building is being installed this week. Swearingin also attended 1015 transit

meeting. The Board is currently faced with a shortage of vehicles and drivers. Swearingin also spoke of other counties who are running into obstacles with upcoming HVAC projects because of inflation.

Seams attended the Republican meeting where the candidates for supervisor were interviewed. Dotts & Swearingin also attended as interviewees. Seams joined Zerr & Dooley on a conference call with Scantron Technology for a 6-month review of IT services. Seams also discussed concerns with the CROSS Region for MHDS (Mental Health Disability Services). Seams also discussed the debt of the Access Center located in Osceola and their request for an additional \$600,000 in allocation from the CROSS Region. Dotts also wanted to express his gratitude for all of the Memorial Programs that were held over the weekend and the great participation of all those in attendance.
