Wayne County Board of Supervisors

Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 22nd day of August 2022, in the Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were David Dotts, Tom Swearingin, Don Seams members of the Board, Randy Zerr, Dan Carpenter, Mark Winslow, Roger Winslow, Leroy Perkins, Susan Moore, Corey Metzger(Zoom) Ericka Graves, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page. Unless otherwise noted, all motions are approved unanimously by all Board members present.

Dotts called the meeting to order at 9:02AM and took roll call.

Pledge of Allegiance

Swearingin made a motion to approve the August 22, 2022, agenda, seconded by Seams.

Seams made a motion to approve the August 8, 2022, minutes, seconded by Swearingin.

Swearingin made a motion to approve the August 19, 2022, Payroll, seconded by Seams.

Seams made a motion to approve the August 22, 2022, claim set, seconded by Swearingin.

No public comments regarding agenda items.

Dotts read the Proclamation from Governor Kim Reynolds proclaiming September 4- 10, 2022 as the Iowa 99 County Bible Reading Marathon. Also, Dotts read a letter from Leslie Mason & Catherine Blackford requesting the Bible reading for Wayne County be set for September 7- 11, 2022 from 6AM to 10PM. Swearingin made a motion to approve the Bible reading on the courtyard, September 7-11, 2022, from 6AM to 10PM, seconded by Seams.

Corey Metzger with Resource Consulting Engineer LLC gave an update on the Courthouse HVAC Project by Zoom. Metzger has set Sept 28th as the target date to have the bid documents ready to begin accepting bids. Metzger is recommending October 28th on Thursday as the deadline for accepting bids with a 2-week window for approving the winning bid. Corey discussed the options of doing the project in phases or moving offices out of the courthouse. This could reduce the project time from 4.5 months to 3 months and generate a \$50,000 savings. Metzger requested the Board to think about their options, visit with the offices impacted by the project and to be prepared to make a decision at the September 19, 2022, if the project will be done in phases or if the courthouse will be turned over to the contractor for the project.

Susan Moore was present on behalf of the Public Health Nursing Department. Public Health is requesting approval for replacing the lighting in the large conference room in their facility. A bid from L W Electric was presented for \$1,200. Swearingin made the motion to approve the new lighting, seconded by Seams.

Swearingin mentioned that today is the last board meeting for County Engineer, Randy Zerr and thanked him for his service. Dotts, Carpenter and Dooley also Thanked Zerr for all of his service for Wayne County.

Zerr reported that the seeding for Medicine Creek project should be getting completed and that Secondary Roads is working on the bridges for 150th and Sunnyslope as well as the low water crossing on Cedar.

Roger Winslow was present to offer the county a \$1 million donation to pave 105th Street to the Rock Valley Lake, which is a farm-to-market road. Mr. Winslow spoke of his history with Voltmaster Co., Inc. which dates back to 1957 and at that time Voltmaster Co, Inc. was one of approximately 200 automotive battery manufacturers in the United States. Today, battery manufactures have dropped off dramatically but Mr. Winslow partnered with East Penn Manufacturing in 2006 to keep the factory in Corydon open and thriving. Since then, East Penn Manufacturing has expanded their Corydon plant operations by \$200 million through a major expansion and has generated additional jobs for our residents. With the additional jobs comes the challenge of housing and Mr. Winslow believes there is a need for at least 200 more housing units in the county. By paving 105th Street to the Rock Valley Lake it opens up opportunities for additional housing development projects. Mr. Winslow stated that we always should be preparing ourselves for the next opportunity that presents itself and that is what he is trying to do for Wayne County. Mr. Winslow would like the project to be completed within 2 years. Leroy Perkins was present regarding the project. Although he liked the idea of a paved road by his house, he expressed concern with access to his home during the project. He also voiced concerns about his land being disturbed for the road and ditches. Zerr stated that it should be an overlay of the existing rock road and they would make sure that he had access to his home. There was also discussion about his property valuation increasing because of a paved road but Dotts visited with the Assessor and his value and tax liability should not increase because of the improvement to the road.

Randy Zerr, County Engineer & Dan Carpenter, Assistant Engineer spoke on behalf of the county, they were thankful for the generous offer but thought the time constraint would be difficult to meet and asked for the start date to be pushed back. The engineer's office would have to get approval from lowa DOT before making the improvement to the road and it would take time to get the Farm-to Market funding secured for such a project. Carpenter spoke of other projects that were already on their current schedule with funding being committed to those projects. TSwearingin made a motion to table the 105th Street Improvement/Mr. Winslow's Donation to the September 6th meeting, seconded by Seams.

City of Lineville, lowa requesting abatement of future taxes for parcel#12300G452017. Swearingin made motion to approve abatement of future taxes for parcel#12300G452017, seconded by Seams.

Seams has spoken with Decatur County and Lucas County supervisors regarding their County Engineer filling in as Interim Engineer for Wayne County. Decatur County Supervisors are willing to discuss options with all the Wayne County Board of Supervisors Monday, August 29, 2022, with no decisions being made that day.

Seams made a motion to table the discussion of the engineer job posting until after their meeting with Decatur County, seconded by Swearingin.

Clerk of Court July Report was presented. They deposited \$836.32. Seams made a motion to accept the Clerk of Court's July Report, seconded by Swearingin.

Swearingin attended the Wayne County Conservation meeting. The DNR is shocking a lake up north and working with Kenny to restock Medicine Creek. Tom mentioned that the Humeston Lake had a huge fish kill due to lack of oxygen.

Seams attended the Executive Director Board meeting for the South-Central Iowa Workforce Development Area. Everything is going well. Seams will be attending Iowa State Association for Counties Conference later this week.

Dotts attended the Townhall meeting with Senator Chuck Grassley and Dotts signed the contract between Wayne County and Kim Crawford, Circle of Freedom Director.
