

Wayne County Board of Supervisors

Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 6th day of September 2022, in the Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were David Dotts, Tom Swearingin, Don Seams (By Phone) members of the Board, Dan Carpenter, John Sellers, Jill Housh, Nancy Bennett, Aaron Hoelting, Bill Byrns, Mary Helen Miller, Jeremie Ruble, Ericka Graves, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page.

Unless otherwise noted, all motions are approved unanimously by all Board members present.

Dotts called the meeting to order at 9:01AM and took roll call.

Pledge of Allegiance

Swearingin made a motion to approve the September 6, 2022, agenda, seconded by Seams.

Swearingin made a motion to approve the August 22 & 29, 2022, minutes, seconded by Seams.

Swearingin made a motion to approve the September 2, 2022, Payroll, seconded by Seams.

Swearingin made a motion to approve the September 6, 2022, claim set, seconded by Seams.

No public comments regarding agenda items.

Swearingin made a motion to approve Nancy Bennett's request for a letter of intent for \$16,000 support to the Walldog Committee, seconded by Seams. The Walldog committee is planning an event for August-September 2023 for several murals to be painted and hung throughout the county. There is over 200 artists signed up for the event and a murals will be hung in all 8 incorporated cities.

Swearingin made a motion to approve Jill Housh's request for a reassignment of tax sale certificate 19-0507 (Parcel12140G404002) seconded by Seams.

Jerry Fetters requested his agenda item be rescheduled for the September 19th meeting.

Swearingin made a motion to approve the Proclamation recognizing September 16, 2022, as POW/MIA Day in Wayne County, seconded by Seams.

Seams made a motion to approve the Proclamation supporting Operation Green Light for Veterans, seconded by Swearingin.

John Sellers spoke on behalf of the Southern Iowa Development & Conservation Authority (SIDCA) and gave the history of the authority.

Swearingin made a motion to approve Contract # 2023.15 between Wayne County and Central Iowa Tourism Region, seconded by Seams.

Swearingin made a motion for the Department of Human Services in Osceola to dispose of the filing cabinets that are identified as Wayne County property as they see fit, seconded by Seams.

Auditor Dooley reported that Mr. Roger Winslow stopped by their office and verbally revoked his offer of \$1 million for the 105 Street improvement because his time requirement cannot be met by the county. The Board thanked Mr. Winslow for his generous offer and for everything he has done for the county.

Jeremie Ruble was present to discuss his concerns relating to 140th Street south of Raccoon Road as well as the letter he received from the prior county engineer, Randy Zerr. He would like to request the county be held to the same standards as the residents of Wayne County are held to about keeping the right-of-way cleared.

Dan Carpenter, Assistant Engineer gave an update of the low water crossing on Cedar Road. Concrete is being poured for that structure. Carpenter also stated that the Secondary Road department will be starting the patching project in the next month. Seams asked about the grass kill situation; Carpenter stated the city of Corydon has replaced the culvert and Chris Furlin will be doing some new seeding on that project. There was a question about the Sunny Slope bridge project and that is still an active project, but the bridge crew has been pulled off to help with the low water crossing project.

Swearingin made a motion to approve the 28E agreement with Decatur County, seconded by Seams. Dillion Davenport will be the interim engineer while Wayne County seeks a new engineer.

Swearingin made a motion to approve a temporary pay increase of \$1,700 per month dated back to August 29, 2022, for Assistant Engineer, Dan Carpenter, seconded by Seams.

Seams made a motion to table revising the engineer job posting until an agreement can be reached for a mentor engineer, seconded by Swearingin.

No Monthly Department reports.

Swearingin attended 1015 transit meeting and department head/elected official meeting.

Seams had no meetings to report on.

Dotts attended Wayne County Development meeting they are considering their options for a new Executive Director. Dotts attended the department head/elected official meeting. The department heads/elected officials met to discuss options of staying in the courthouse or moving out of the courthouse during the HVAC project.

Seams did not attend the department head/elected official meeting regarding the courthouse HVAC project but wants to make sure that all options are explored and he would like the HVAC project to be quoted both ways; with the offices remaining in the courthouse or the offices being relocated during the project.
