

Wayne County Board of Supervisors

Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 17 day of October 2022, in the Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were David Dotts, Tom Swearingin, Don Seams(By Phone) members of the Board, Dan Carpenter, Caleb Housh, Jack Reed Ericka Graves, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page.

Unless otherwise noted, all motions are approved unanimously by all Board members present.

Dotts called the meeting to order at 9:07AM and took roll call.

Pledge of Allegiance

Swearingin made a motion to approve the October 17, 2022, agenda, seconded by Seams.

Swearingin made a motion to approve the October 3, 2022, minutes, seconded by Dotts. Seams abstained from voting.

Swearingin made a motion to approve the October 14, 2022, Payroll, seconded by Dotts. Seams abstained from voting.

Swearingin made a motion to approve the October 17, 2022, claims set, seconded by Dotts. Seams abstained from voting.

No public comments regarding agenda items.

Swearingin made motion to table the tax abatement for the City of Allerton for parcel# 10100D237014 & 10100D237015, seconded by Dotts.

Mayor Caleb Housh discussed tax abatement for parcel# 12230C203002 which the city currently holds title to. Currently, there is no taxes due so there are no taxes to abate so no action taken. Mayor Housh also gave an update on the properties on the east side of the Seymour square and reported that the city is waiting on the asbestos testing that was done recently. He will keep the Board informed as they go through the process of getting title switched over to the city and getting the buildings removed.

Dan Carpenter, Assistant Engineer gave the following updates.

Medicine Creek is complete and working on the paperwork to close out the project.

Pavement Stripping Contract Project is complete and final acceptance of work (Form 435) has been signed.

PCC Overlay of J-46 project (3-mile section east of S-40) has been awarded to Manatt's Inc.

Bridges-

- 150th Street, south of Highway 2 – steel beams were installed on Thursday, August 4, 2022.
- Sunny Slope, east of Highway S-56 – steel beams were installed on Thursday, August 4, 2022 installing diaphragms and then decking.
- 105th Street, north of Fillmore Road – waiting to drive piling
- Birch Road – bid letting was Tuesday, March 15, 2022, and Iowa Bridge & Culvert, L.C. was the lowest bidder (\$969,749.60); pre-construction meeting with contractor was held on Sept. 21st. Anticipated start date is between November 15th & Thanksgiving. Late start date of May 1, 2023. 90 working days. Free winter work is allowed.
- Bridge on 180th between Birch and Cedar will be replaced with a railroad tanker car.
- Jubilee Road – design plans are being developed in-house including acquisition plats for additional right-for-way on both sides of the road.

Low Water Crossings

- Cedar Road – Construction is now complete.
- 55th Street – scheduled to commence in the fall of 2022 / spring 2023
- Payton Road – scheduled to commence in the fall of 2022 / spring 2023

The motor grader operators are currently mowing the whole right away of county highways and a strip for rock roads.

Patching crew continues to work this week and have completed several areas already and are utilizing traffic lights for some patches.

Brush grinding will occur later in the fall and through the winter months after some low water crossing and culvert projects are completed.

The job posting for equipment operator has closed and received several applicants and will be setting up interviews soon.

Dotts passed on the "Thank you" that he has received from several throughout the county for mowing. Carpenter also reported that the signs for the Mormon Trail has been received and they will be installed in the near future.

Swearingin made a motion @ 9:25AM to go into a closed session pertaining to Code Section 20.17(3), seconded by Dotts.

During closed session Seams left the meeting unexpectedly.

Swearingin made a motion @ 10:22AM to come out of closed session and back into regular session, seconded by Dotts.
 Swearingin made a motion to accept the Recorder's September Report, seconded by Dotts. The deposits were \$ 6,613.23.
 No Discussion.

Supervisor meetings:

Swearingin attended Wayne County Conservation meeting. The conservation department is getting ready for winter, and they are hosting a Halloween event the weekend of October 22nd with trick or treating and a chili cook off.

Dotts attended the annexation meeting held for the City of Corydon and he attended the Pioneer Days at the Prairie Trails Museum. There was a large turnout, and the wood carving exhibit was a huge hit.
