 - a. IDNR started stocking the lake, first round was Thursday the 4th
 - b. 60 Bluegill, 20 Redear Sunfish, 8 Crappie, 2 Catfish, 4 Large Mouth Bass
 - c. Is full of water and being stocked with nice fish. Three to four years should make good fishing again.
- D. Lakeside Park had a blue algae bloom causing a fish kill, what a mess and sad to see the nice fish go to waste
- E. Camping is down, shelter rentals are average


