

Wayne County Board of Supervisors

The Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 8th day of August 2023, in the Lower-level Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were Lance Lange, and Chris Moore, members of the Board. Also in attendance: Nancy Bennett, Jathan Chicoine, Mike Cockrum, Dan Carpenter, Dillon Davenport, John Sellers, Jenny Nickell, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page.

Unless otherwise noted, all motions are approved unanimously by all Board members present.

Lange called the meeting to order at 10:01AM and took roll call.

Pledge of Allegiance

Lange made a motion to approve the agenda with the removal of item 12) Contract between Wayne County Development Corporation and Wayne County, seconded by Moore.

Moore made a motion to approve July 25, 2023, Minutes, seconded by Lange.

Lange made a motion to approve August 4, 2023, Payroll, seconded by Moore.

Moore made a motion to approve August 8, 2023, Claim Set, seconded by Lange.

No public comments on agenda items.

Jathan Chicoine with Home Base Iowa (HBI) was present to speak of the program and to request Wayne County's support and participation. Home Base Iowa is a one-of-a-kind public/private partnership connecting Veterans, military personnel and their families with resources and opportunities in Iowa. There has been many changes with the program over the development and operations of the program. Recently 5 HBI Career Planners were hired in January 2022. Over 382 Veterans and spouses have been able to find meaningful employment through the program. As HBI is developing and expanding, Mr. Chicoine requested Wayne County to continue to be a participant of the program. Mr. Chicoine also stated that typically speaking their partnership would work with the Veteran Affairs Office or with the Economic Development Office.

There are 5 requirements to be recognized as a Home Base Iowa County.

- 1) The Board of Supervisors must pass a Resolution stating their intent to participate and support HBI.
- 2) Designate Businesses to partner with.
- 3) Establish incentive package.
- 4) Place HBI signage around the county
- 5) Hold dedication ceremony.

Mike Cockrum was also with Mr. Chicoine at the meeting. Mr. Cockrum is the Operation Manager for the American Job Center based out of Ottumwa. The Board thanked them both for their attendance and agreed to look at the budget to determine what types of incentive packages the county may be able to offer and to schedule a work session in the future with them.

John Sellers was present to give updates for Southern Iowa Development & Conservation Authority (SIDCA) & The Rathbun Water & Land Alliance.

Engineer Dillon Davenport gave an update on the road department. The bridge crew has moved to 150th Street bridge but are waiting for falsework & forms from Decatur County. So, the crew is currently mowing roadside ditches while they wait. Davenport is hoping to finish this bridge before winter. Then the crew is moving to the bridge south of Allerton by the feedlot. Davenport expressed that the county is buying a pile driver for the excavator. This will be much safer and quicker than using a crane. The crew will work through the winter building the forms and plan on pouring the deck in the spring dependent upon the temperatures. Mark McClain is working hard on installing culverts. Currently he is able to lay approximately one a day but that will slow down when he starts working on larger projects. Davenport spoke about their visit with the Van Diest Supply chemical rep regarding some different options for brush control. Van Diest is recommending their focus be on the 12-18-month-old trees because it will be more effective.

Moore made a motion to approve the engineer, Dillon Davenport's contract amendment, seconded by Lange. The amendment allows Engineer Davenport to accrue vacation at 9 hours monthly and entitled to carry over up to one (1) year's vacation accrual forward. Also, Engineer Davenport's sick leave will be accrued and capped consistent with the other Secondary Roads Department Staff.

Lange made a motion to approve the Clerk of Court July Report, seconded by Moore. Deposits \$482.91

Moore made a motion to approve the Public Health Nursing May, June & July Report, seconded by Lange. Deposits; May \$41,465.81, June \$26,784.54 & July \$36,064.54

Lange made a motion to approve the Recorder's July Report, seconded by Moore. Deposits \$4,837.35

Moore made a motion to approve the Sheriff's July Report, seconded by Lange. Deposits \$53,315.53

No discussion items.

Supervisor Moore visited with US Representative Zack Nunn and two of his staff members yesterday at Corydon City Hall. They discussed funding options for restoring Wayne County Lakes and Reservoirs. Moore also stated that the job posting for the IT Director position has closed and that the interview process will begin soon.

Lange had no meetings to report.

Public Comments:

Nancy Bennett, Interim Economic Development Director gave an office update. She received confirmation that a \$10,000 childcare grant has been awarded to Wayne County. The Corydon Senior Meal site location sale closed in July. They are working hard on the Walldog Project that is coming up the end of August. She attended a zoom meeting pertaining to Envision Iowa. She continues to work with Supervisor Moore to find funding for the Lakes and Reservoir cleanup efforts.
