

Wayne County Board of Supervisors

The Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 25th day of July 2023, in the Lower-level Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were Lance Lange, and Chris Moore, members of the Board. Also in attendance: Nancy Bennett, Dan Carpenter, Don Seams, Jenny Nickell, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page.

Unless otherwise noted, all motions are approved unanimously by all Board members present.

Lange called the meeting to order at 10:00AM and took roll call.

Pledge of Allegiance

Lange made a motion to approve the agenda with an additional item; Courthouse HVAC Project & Courthouse offices vacating the premises, seconded by Moore.

Moore made a motion to approve July 11, 2023, Minutes, seconded by Lange.

Lange made a motion to approve July 21, 2023, Payroll, seconded by Moore.

Moore made a motion to approve July 25, 2023, Claim Set, seconded by Lange.

No public comments on agenda items.

Assistant Engineer Dan Carpenter gave an update on the road department. The Dura Patcher has arrived. Sunny Slope bridge is open for traffic. The bridge crew is moving to 150th Street bridge. Carpenter and Davenport visited with the Van Diest Supply chemical rep regarding some different options for brush control.

Lange made a motion to approve the capital asset addition of DuraPatcher trailer (#58) w/diesel tank along with the tank system (#59), seconded by Moore. The DuraPatcher and tank system was purchased from Star Equipment for a total cost of \$120,757.

Lange made a motion to accept the bid from Ruiz Construction to scrape and paint the exterior of the courthouse for \$19,807, seconded by Moore. The contractor has agreed to an August 21st start date. Walldog artists are scheduled to begin prep work on the north side of the courthouse August 22nd thru 24th.

The two bids received were as follows:

Moore made a motion to appoint Brenda Dodson to the City of Corydon, Board of Adjustment, as their representative, seconded by Lange.

Moore will remain on just the Wayne County Public Health Board while Lange will remain on the Wayne County Home Care Aide Agency Board (Homememakers) to allow equal representation for each entity.

Lange spoke of the Courthouse HVAC project since meetings with the contractors have begun. The courthouse offices will vacate the premises during this project. Offices will be relocated by midnight on January 14th, 2024. The project is scheduled to take 6 months. Lange spoke about different options for relocating courthouse offices and asked for the public's patience through this process.

Lange made a motion to approve the Clerk of Court June Report, seconded by Moore. Deposits \$1,019.70

Lange made a motion to approve the Sheriff's June Report, seconded by Moore. Deposits \$4,755.81

No discussion items.

No Supervisor Meetings to report.

Public Comments:

Don Seams was present to express his appreciation of the Board of Supervisors doing their research before making a decision on different matters. He also thanked Secondary Roads for getting the Sunny Slope bridge back open for the public and for continuing their efforts to control the brush in the county ditches because of safety concerns.
