

Wayne County Board of Supervisors

The Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 14th day of November 2023, in the Wayne County Courthouse; Lower-level Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were Lance Lange, Chris Moore, and Todd Wilson, members of the Board. Also in attendance: Shelley Bickel, Mendy Middlebrook, Kellie Anderson, Dillon Davenport, Dan Carpenter, Don Seams, Jenny Nickell, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page.

Unless otherwise noted, all motions are approved unanimously by all Board members present.

Lange called the meeting to order at 10:00AM and took roll call.

Pledge of Allegiance

Wilson made a motion to approve the agenda, seconded by Moore.

Moore made a motion to approve October 31, 2023, Minutes, seconded by Wilson.

Lange made a motion to approve November 10, 2023, Payroll, seconded by Moore.

Wilson made a motion to approve November 14, 2023, Claim Set, seconded by Moore.

No public comments on agenda items.

Mendy Middlebrook, Wayne County CPC for County Rural Offices of Social Services (CROSS) Mental Health Region presented an amendment to the 28E agreement between CROSS and the county. The 28E amendment was the result of legislative changes. Two (2) additional seats were established for the CROSS Board. Moore made a motion to approve the Amended and Restated 28E Agreement with CROSS, seconded by Wilson.

Engineer Dillon Davenport reported that the grinding crew is working on 50th Street south of Liberty Road. A culvert is being repaired on S40 north of Sewal. The bridge crew is scheduled to pour the decking on 150th Street Bridge this Friday, November 17th. The mowing crew should be down with mowing the county pavements this week.

Monthly Department Reports

Shelley Bickel, Public Health Nursing Director gave a monthly report.

September deposits totaled \$39,901.93.

October deposits totaled \$42,131.89.

Bickel also gave a report of the Vision to Learn Program. This program is a 5-year program. It will provide eye exams for all students in all three school districts located in Wayne County. At Seymour CSD, 60 elementary students were referred to the program to which 15 students will receive 2 pairs of glasses. One pair will be left with the school nurse and the 2nd pair will be worn by the student. The van will be returning to Seymour on November 16 & 17 for Junior High & High School students. The van is scheduled to be at Wayne CSD the 2nd week of January and at Mormon Trail CSD, end of January for 3 days.

Bickel also reported that they have a High School student assisting with the handwashing program being offered in the schools. 287 students participated in the program.

Heather Sharp is a new nurse hired by Bickel. Part of Sharp's job duties are to provide nursing services to the Seymour CSD(Thursday) & Mormon Trail CSD(Tuesday) each week.

There have been no more discussions about regionalizing County Public Health Departments by the State.

Public Health is providing services to the Circle of Freedom Program the 1st Monday of every month with a specific emphasis each month for the students enrolled.

Public Health has received a grant to fund 1st Aid Kits to be given to all the teachers in the county.

Public Health offers DOT drug testing for school bus drivers and the schools pay for that service. Covid & Flu shots are now available by appointment. Aaron Hoelting, Courthouse Maintenance and Custodian is doing a great job getting the facility ready for the clerk of court and judicial system to relocate in early January. Bickel is very pleased with Hoelting workmanship and dedication.

Wilson asked if Public Health can also provide random drug testing for different employers located in the county. Bickel will look into that service.

Kellie Anderson, Wayne County Development Corporation Director reported that she started October 23rd and is working on reading through minutes and getting familiar with the different projects being worked on right now. Anderson is also working on Jenna Lain to get all the corporation taxes reviewed and updated.

Monthly Department Reports

Lange made a motion to approve the Public Health Nursing September Report, seconded by Wilson. Deposit totaled \$39,901.93.
Lange made a motion to approve the Public Health Nursing October Report, seconded by Wilson. Deposit totaled \$42,131.89.
Moore made a motion to approve the Clerk of Court October Report, seconded by Wilson. Deposit totaled \$572.16.
Moore made a motion to approve the Sheriff's October Report, seconded by Wilson. Deposit totaled \$22,609.61.
Wilson made a motion to approve the Recorder's October Report, seconded by Moore. Deposit totaled \$4,226.58.

Supervisor meetings:

Moore attended the Wayne Ringgold Decatur (WRD) Landfill meeting. The board is considering purchasing a different compactor for the landfill which should improve compaction and result in a longer life for a cell.
Lange attended the First Friday Coffee. There is a lot of good things going on in the county and the county has a whole is represented well by a variety of participants. Lange spoke of a study being conducted that will help develop a county wide committee that can collaborate and share resources moving forward. This study is being done by the University of Northern Iowa and is paid for by third party donors throughout the county. Lange was unable to attend Conservation Board meeting but gave an update from Director Kenny Banks. Conservation will not need a new mower this year. However, they would like to redirect those funds to purchase a stump grinder for the skid steer. Also, the parks are now closed for the season. however, a crew from the City of Corydon and Conservation are working on installing the new playground at the Corydon Lakeside Park.
Wilson also attended the First Friday Coffee held at the office of Wayne County Development and the Wayne Community Foundation. Wilson spoke of the great networking that is taking place at the meeting. First Friday Coffee will be moving to the First Thursday of the month. Wilson also attended a South-Central Iowa Workforce Development meeting by phone. He plans on attending the next meeting on February 1st in person since it was hard to hear. He spoke about the reentry program for inmates and One Stop Certification in Marshalltown. Wilson is still trying to gather information from the Milestone Program for congregate meals.

Discussion: Dooley stated that the funding for the newly hired position of Director for Wayne County Development is supported 60% by county and 40% by other entities within the county. There is a lot growth and collaboration going on the Wayne County.

Public Comment:

Don Seams wanted to make sure that conservation does a thorough research when purchasing a stump grinder. Not all stump grinders are comparable. Seams also mentioned that Milestone helps with the 18-80 Club in Centerville and Wilson may want to visit with them. Lange thanked Don Seams for writing articles covering the Board of Supervisor's meetings for the Seymour Herald as well as Jenny Nickell for writing for The Times Republican and New Era. They both are greatly appreciated and helps to communicate important messages to the residents.
