

Wayne County Board of Supervisors

The regular scheduled meeting of the Wayne County Board of Supervisors was held on the 11th day of June 2024, in the Wayne County Development Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were Lance Lange, Chris Moore, and Todd Wilson, members of the Board. Also in attendance: Amanda Cooper, Keith Davis, Kellie Anderson, Chase Clark, Dillon Davenport, Dan Carpenter, Don Seams, Savannah Sandy, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page.

Unless otherwise noted, all motions are approved unanimously by all Board members present.

Lange called the meeting to order at 10:00AM and took roll call.

Pledge of Allegiance

Moore made a motion to approve the agenda with one additional item added; Discuss current policy regarding if an employee has a complaint with their direct supervisor, seconded by Wilson.

Lange made a motion to approve the May 28, 2024, regular meeting minutes, seconded by Moore.

Moore made a motion to approve June 7, 2024, payroll, seconded by Lange.

Wilson made a motion to approve June 11, 2024, claim set, seconded by Moore.

There were no public comments on agenda items.

Don Seams wanted to know when the public could expect a semi-annual report from Treasurer, Amanda Cooper which is required per Iowa Code Section 331.55(4) and 349.16. Cooper was appointed in July 2021. The last semi-annual was published April of 2022. The county changed its financial program in April 2022 and there have been challenges with reconciling the main bank account since the conversion. Treasurer Cooper is working with the State Auditor's Office to identify the discrepancies and they are making progress in getting the main bank account reconciled. Treasurer Cooper has also worked with Tyler Technology to resolve these balancing issues. Treasurer Cooper is very close to publishing the semi-annuals once she is confident the information is correct.

Engineer Dillon Davenport gave Engineer Office/Secondary Road Update.

- The bridge crew on 105th St near Allerton poured the concrete for the deck and should be open for traffic in 2 weeks.

- The railroad tanker car on 190th Street south of the Highway is in place and that street should be open for traffic in 2 weeks.

-TK Concrete signed the contract to do the patching and shoulder work north of Sewal and they are scheduled to begin work in August. There are some concerns about the truck traffic on this highway in August.

-The Kenworth semi that was purchased through Purple Wave has been picked up. This semi is replacing the one involved in the accident west of Corydon in March.

Moore made a motion to approve the 28E agreement with Appanoose and Davis County to share portable traffic signals, seconded by Wilson. Appanoose County applied for a \$60,000 grant to purchase the signals and will retain ownership of the lights after the 10-year 28E share agreement.

Lance made a motion to approve IT Director, Chase Clark, to terminate the Service Agreement with Scantron Technology with the assistance of the county attorney and to secure other IT managed services, seconded by Moore.

Lange discussed that the County HR consultant, Jack Reed wanted the supervisors to discuss their policy if an employee has a complaint against a department head who should they report it to. Reed is recommending that a 3rd party mediator be designated to handle such circumstances. Sheriff Davis reminded the Board of Supervisors that his deputies are covered under civil service.

Monthly Reports:

Lange made a motion to approve the Recorder's May Report, seconded by Moore. The deposits were \$7,572.79.

Auditor Dooley reported that the total cash held by financial institutions for Wayne County as of April 30, 2024, is \$12,538,207.40.

Supervisor Meeting Updates:

Lange attended the Wayne County Conservation meeting. Everything is going well. Camping was a little down over the Memorial Weekend. The new zipline at Corydon Park is a great success. Director Kenny Banks has not found a brush cutter to purchase.

Lange also attended First Thursday Coffee at Development. Very positive upbeat meeting where like-minded individuals can come together to discuss events going on in the county and programs that can move the county ahead. Lange will be going on a tour with the Kading Developers to showcase what Wayne County has to offer potential new residents.

Moore attended the CROSS mental Health Region meeting. Ward Graham, Decatur County Supervisor and Moore will sit on the mental health governing board for the newly developed region beginning July 1st. Homemakers is merging with Public Health Nursing effective June 16, 2024. There will be no change in services offered by the homecare aides. Any funds that Wayne County Home Care Aide Agency has of July 1st will be given to the Wayne County Foundation to oversee and distribute. Moore also attended the WRD Landfill meeting, and the future of the landfill is better than originally thought.

Wilson had no meetings to report on.

Public Comments

Sheriff Keith Davis reported that the Wayne County Public Health Department will continue providing medical services to the inmates in FY25. The Sheriff's Office has ordered a 2024 silver Tahoe to add to their fleet.
