

Wayne County Board of Supervisors

The regular scheduled meeting of the Wayne County Board of Supervisors was held on the 25th day of June 2024, in the Wayne County Development Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were Lance Lange, Chris Moore, and Todd Wilson, members of the Board. Also in attendance: Dillon Davenport, Dan Carpenter, Don Seams, Savannah Sandy, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page.
Unless otherwise noted, all motions are approved unanimously by all Board members present.

Lange called the meeting to order at 10:00AM and took roll call.

Pledge of Allegiance

Moore made a motion to approve the agenda, seconded by Wilson.

Lange made a motion to approve the June 11, 2024, regular meeting minutes, seconded by Moore.

Wilson made a motion to approve the June 20, 2024, work session meeting minutes, seconded by Moore.

Moore made a motion to approve June 21, 2024, payroll, seconded by Lange.

Lange made a motion to approve June 25, 2024, claim set, seconded by Moore.

There were no public comments on agenda items.

Engineer Dillon Davenport gave Engineer Office/Secondary Road Update.

- Exploring options to improve the river bottom section of East Old Highway 2. The dura patcher is not a good option since there is a lot of rebar exposed. Covering with road rock is not a good long-term option. The best option is grinding up and relaying the base and then topping on with road rock. It is approximately ½ mile stretch and if anything is done it will be in August or later.
- Been working with the Board of Supervisors on a revised Memorandum of Understanding for Secondary Roads/Engineer's Office.
- Starting to see blowups throughout the county which is common this time of year
- A bridge replacement with a railroad tanker car on 150th Street south of the Howe.
- Met with TK Concrete contractor for the shoulder/drainage project may begin next week.
- The bridge crew on 105th St near Allerton is open for traffic.
- 190th Street is open for traffic.

Wilson made a motion to approve the Memorandum of Understanding for Secondary Roads, seconded by Moore. This MOU supersedes all previous relevant policies.

Moore made a motion to approve the Asset deletion of #76 2006 Kenworth Semi, seconded by Wilson. This semi was involved in the accident west of Corydon and was purchased back from the insurance company for parts.

Wilson made a motion to approve the Asset deletion of 2019 Pro-turn Gravely Lawnmower, seconded by Moore. This lawnmower was traded in.

Wilson made a motion to approve Resolution 24-27, seconded by Moore.

Supervisor Meeting Updates:

Lange attended the work session for the MOU and Employee Handbook.

Wilson attended a Milestone Advisory Committee meeting via Zoom. They are trying to develop partnerships within the county and working on developing better lines of communication for the programs they offer.

Moore attended the New Venture Group Home Advisory committee meeting. The home currently has 4 residents and is working on updating the cupboards and flooring.

Discussion: The County offices that are currently located on the 1st Floor of The Brick are scheduled to move back to the courthouse July 18-22nd. Offices will be closed for business.

Public Comments

Don Seams asked what the major changes in the employee handbook are. Two (2) of the major changes are: All employees will be able to use vacation as they earn it after six-month probationary period. Eligible employees, who have worked for the county for 15 years or more may receive a 40% payout of sick time banked to go toward health insurance premiums with no lapse in coverage. Seams also talked about his experience of the Milestone Programs and the biggest obstacle is program longevity.
