

Wayne County Board of Supervisors

The regular scheduled meeting of the Wayne County Board of Supervisors was held on the 23rd day of July 2024, in the Wayne County Development Conference Room, Corydon, Iowa, pursuant to notice duly given in compliance with the Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were Lance Lange, Chris Moore, and Todd Wilson (By Phone), members of the Board. Also in attendance: Dillon Davenport, Dan Carpenter, Kellie Anderson, Don Seams, Savannah Sandy, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page. **Unless otherwise noted, all motions are approved unanimously by all Board members present.**

Lange called the meeting to order at 10:02AM and took roll call.

Pledge of Allegiance

Lange made a motion to approve the agenda, seconded by Moore.

Moore made a motion to approve the July 9, 2024, regular meeting minutes, seconded by Wilson.

Moore made a motion to approve July 19, 2024, payroll, seconded by Wilson.

Lange made a motion to approve July 23, 2024, claim set, seconded by Moore.

There were no public comments on agenda items.

Engineer Dillon Davenport gave Engineer Office/Secondary Road Update.

- Patching north of Sewal on S40 is going slow, TK Concrete Inc sent a small crew
- Railroad tank car on 150th Street south of Howe Rd is going well and should be open to traffic later this week.
- Shoulder rock was pushed back until August 5th, the quarry ran out of rock
- Several blow-ups on the county paved roads and doing a temporary fix with the Durapatcher until later in August.
- The bridge crew is helping with the railroad tanker car project and with Durapatching.
- Still mowing roadsides and spraying brush

A new Mechanic II position for Secondary Roads has been created and Engineer Davenport recommended Roy Benda to fill the position. Benda is the current mechanic for the county and was the only applicant. Moore made a motion to approve Roy Benda to fill the Mechanic II position, seconded by Lange.

Monthly Reports:

Lange made a motion to approve the Clerk of Court Report, seconded by Moore. The deposits were \$680.43.

Moore made a motion to approve the Sheriff's Report, seconded by Lange. The deposits were \$29,184.30.

Supervisor Meeting Updates:

Willson missed the 10-15 transit meeting and has a Southeast Iowa Response Group meeting coming up.

Moore attended the Wayne, Ringgold & Decatur (WRD) County Landfill meeting. They are moving a lot of clay and preparing the roadbed for the next cell to be built. Moore also attended the Wayne County Public Health Board meeting. Public health nursing is doing well as they transition through the consolidation of Homemakers with Public Health Nursing. They are faced with budget challenges as they work through this transition and developing a realistic budget moving forward. Moore also attended the Department Head meeting.

Lange had no meetings to report on.

Discussion: The county offices that were in The Brick have moved back to the courthouse except for the Engineer's Office. They are scheduled to move the week of July 29th.

Public Comments

Don Seams asked if any progress with Tyler Technologies has been made. Lange was not aware of any progress due to the office moves.


